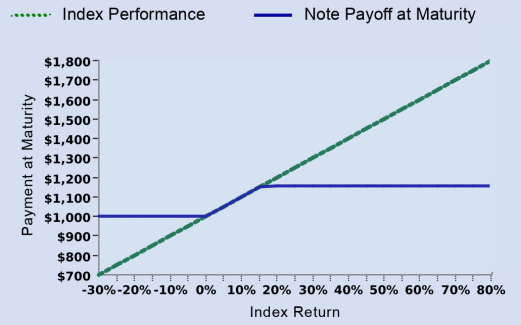

Selected Risks
