

## 5yr GLD/SLV Uncapped Contingent Buffered Return Enhanced Notes

The following is a summary of the terms of the notes offered by the preliminary pricing supplement highlighted below.

## Summary of Terms

**Funds:** SPDR® Gold Trust and iShares® Silver Trust  
**Pricing Date:** November 24, 2020  
**Observation Date:** November 24, 2025  
**Maturity Date:** November 28, 2025  
**Upside Leverage Factor:** At least 1.65\*  
**Contingent Buffer Amount:** 40.00%  
**Payment At Maturity:** If the Final Value of each Fund is greater than its Initial Value, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Lesser Performing Fund Return} \times \text{Upside Leverage Factor})$$

If (i) the Final Value of one Fund is greater than its Initial Value and the Final Value of the other Fund is equal to its Initial Value or is less than its Initial Value by up to the Contingent Buffer Amount or (ii) the Final Value of each Fund is equal to its Initial Value or is less than its Initial Value by up to the Contingent Buffer Amount, you will receive the principal amount of your notes at maturity.

If the Final Value of either Fund is less than its Initial Value by more than the Contingent Buffer Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + \$1,000 \times (\text{Lesser Performing Fund Return})$$

*If the Final Value of either Fund is less than its Initial Value by more than the Contingent Buffer Amount, you will lose more than 40.00% of your principal amount at maturity and could lose all of your principal amount at maturity.*

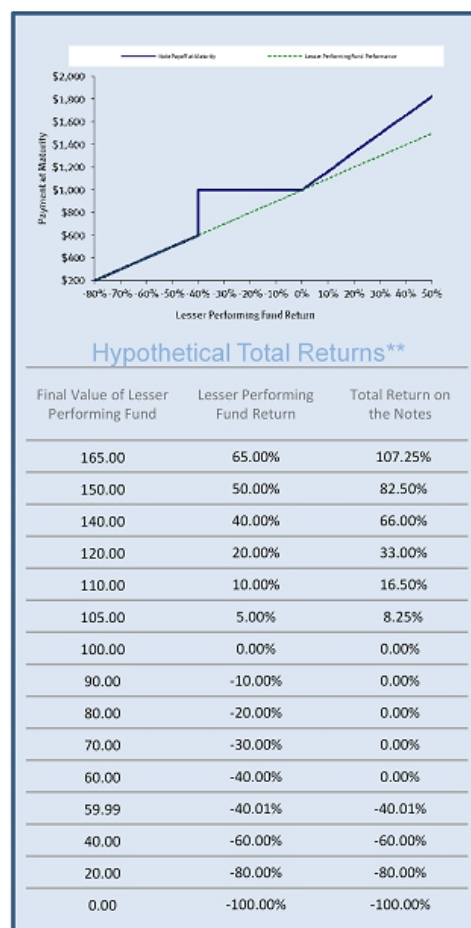
