

## 2.5y EFA Capped Dual Directional Accelerated Barrier Notes

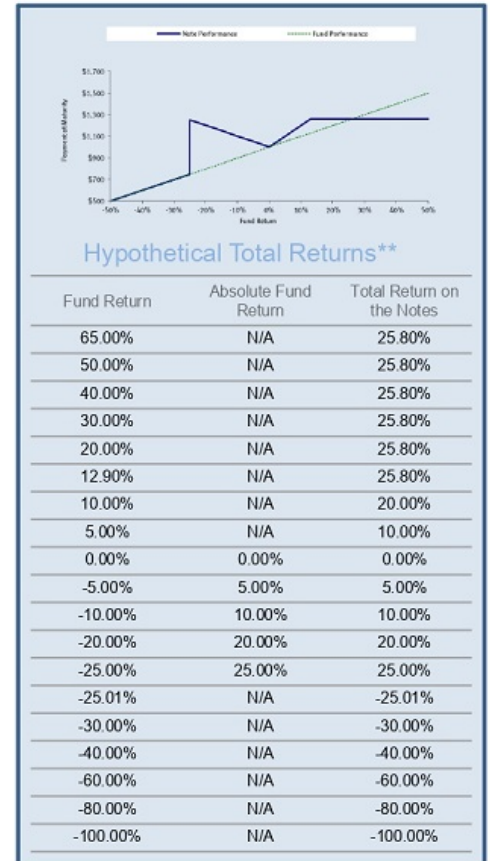

## Selected Risks (continued)
