

JPMorgan Chase & Co. Yield Optimization Notes with Contingent Protection

Investment Description

Yield Optimization Notes with Contingent Protection are unsecured and unsubordinated Notes issued by JPMorgan Chase & Co. (the "Issuer") (each a "Note" and collectively, the "Notes") linked to the performance of the common stock of a specific company (the "Underlying Stock"). The Notes pay enhanced coupons and provide either a return of principal or shares of the applicable Underlying Stock at maturity. The enhanced coupons are designed to compensate you for the risk that you may receive a share of the applicable Underlying Stock at maturity for each Note held that is worth less than your principal. At maturity, you will receive one share of the applicable Underlying Stock (subject to adjustments, in the case of certain corporate events described in the accompanying product supplement no. UBS-8-A-I under "General Terms of Notes — Anti-Dilution Adjustments," in the sole discretion of the calculation agent) for each of your Notes if the closing price of the applicable Underlying Stock on the Final Valuation Date (the "Final Price") is below the specified Trigger Price. Otherwise, you will receive your principal in cash. We will make coupon payments during the term of the Notes regardless of the performance of the applicable Underlying Stock. **Investing in the Notes involves significant risks. You may lose some or all of your principal. The contingent protection feature applies only if you hold the Notes until maturity. Any payment on the Notes is subject to the creditworthiness of the Issuer.**

Features

- q **Income**—Regardless of the performance of the applicable Underlying Stock, we will pay you coupons designed to compensate you for the fact that you could lose some or all of your principal.
- Tactical Investment Opportunity—If you believe the applicable Underlying Stock will trend sideways over the term of the Notes moving neither positively by more than the coupon paid on the Notes, nor negatively by more than the amount of the contingent protection the Notes may provide improved performance compared to a direct investment in the applicable Underlying Stock.

The Notes will be issued in minimum denominations equal to the Principal Amount and multiples thereof. 

The following examples illustrate the payment at maturity on a hypothetical offering of the Notes linked to a hypothetical Underlying Stock assuming the following*:

Hypothetical dividend yield holders of the Underlying Stock might receive over the term of the Notes. If the actual Coupon per Annum as determined on the Trade Date is less than 11.375% (equivalent to 5.6875% over the term of the Notes), your coupon payments over the term of the Notes will be lower than the hypothetical coupon payments and total return shown below

Scenario #1: The Final Price of the applicable Underlying Stock is not below the Trigger Price of \$30.00.

Because the Final Price of the Underlying Stock is not below the Trigger Price of \$30.00, you will receive at maturity a cash payment equal to the principal amount of the Notes. This investment would outperform an investment in the Underlying Stock if the price appreciation of the Underlying Stock (plus dividends, if any) is less than 5.6875%.

If the closing price of the Underlying Stock on the Final Valuation Date is \$40.00 (no change in the price of the Underlying Stock):

Coupons:	\$2.28 (\$0.3792 x 6 = \$2.28)
Total:	\$42.28
Total Return on the Notes:	5.6875%

In this example, the total return on the Notes is 5.6875% while the total return on the Underlying Stock is 0.905% (including dividends).

If the closing price of the Underlying Stock on the Final Valuation Date is \$52.00 (an increase of 30%):

Total:	\$40.00 \$2.28 (\$0.3792 x 6 = \$2.28) \$42.28
Total Return on the Notes:	5.6875%

In this example, the total return on the Notes is 5.6875% while the total return on the Underlying Stock is 30.905% (including dividends).

If the closing price of the Underlying Stock on the Final Valuation Date is \$34.00 (a decline of 15%):

Payment at Maturity:	\$40.00
Coupons:	\$2.28 (\$0.3792 x 6 = \$2.28)
Total:	\$42.28
Total Return on the Notes:	5.6875%

In this example, the total return on the Notes is 5.6875% while the total return on the Underlying Stock is a loss of 14.095% (including dividends).

Scenario #2: The Final Price of the Underlying Stock is below the Trigger Price of \$30.00.

Because the Final Price of the Underlying Stock is below the Trigger Price of \$30.00, you will receive at maturity one share of the Underlying Stock for every Note you hold. The value of shares received at maturity and the total return on the Notes at that time depends on the closing price of the Underlying Stock on the Maturity Date.

If the closing price of the Underlying Stock on the Maturity Date is \$16.00 (a decline of 60%):

Value of Shares Received: Coupons:	\$16.00 \$2.28 (\$0.3792 x 6 = \$2.28)
Total:	\$18.28
Total Return on the Notes:	-54.3125%

In this example, the total return on the Notes is a loss of 54.3125% while the total return on the Underlying Stock is a loss of 59.095% (including dividends).

If the closing price of the Underlying Stock on the Maturity Date is \$22.00 (a decline of 45%):

We will determine the portion of each Coupon Payment that we will allocate to interest on the debt component and to Premium, respectively, and will provide that allocation in the pricing supplement for the Notes. By purchasing the Notes, you agree to treat the Notes for U.S. federal income tax purposes consistently with our treatment and allocation as described above. If the Notes had priced on June 18, 2010, we would have treated as interest on the debt component and as Premium the following amounts:

The actual Coupon per Annum and allocation that we will determine for the Notes may differ from this hypothetical Coupon per Annum and allocation, and will depend upon a variety of factors, including actual market conditions and our borrowing costs for debt instruments of comparable maturities on the Pricing Date. Assuming this characterization is respected, (a) interest on the debt component will be taxed as ordinary income, while the Premium will not be taken into account prior to maturity or sale, and (b) assuming that you are an initial holder of Notes purchasing the Notes at the Initial Price for cash. 


