

2yr SPX Auto Callable Contingent Buffered Return Enhanced Notes

The following is a summary of the terms of the Notes offered by the preliminary pricing supplement highlighted below.

Automatic Call

If the closing level of the Index on the Call Valuation Date is greater than or equal to the Call Value, the Notes will be automatically called for a cash payment, for each \$1,000 principal amount Note, equal to (a) \$1,000 plus (b) the Call Premium Amount, payable on the Call Settlement Date. No further payments will be made on the Notes.

If the Notes are automatically called, you will not benefit from the Upside Leverage Factor that applies to the payment at maturity if the Final Value is greater than the Initial Value. Because the Upside Leverage Factor does not apply to the payment upon an automatic call, the payment upon an automatic call may be significantly less than the payment at maturity for the same level of appreciation in the Index.

Payment At Maturity

If the Notes have not been automatically called and the Final Value is greater than the Initial Value, your payment at maturity per \$1,000 principal amount Note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Index Return} \times \text{Upside Leverage Factor})$$

If the Notes have not been automatically called and the Final Value is equal to the Initial Value or is less than the Initial Value by up to the Contingent Buffer Amount, you will receive the principal amount of your Notes at maturity.

If the Notes have not been automatically called and the Final Value is less than the Initial Value by more than the Contingent Buffer Amount, your payment at maturity per \$1,000 principal amount Note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Index Return})$$

If the Notes have not been automatically called and the Final Value is less than the Initial Value by more than the Contingent Buffer Amount, you will lose more than 25.00% of your principal amount at maturity and could lose all of your principal amount at maturity.
