

2yr SPY/IWM Uncapped Accelerated Barrier Notes

The following is a summary of the terms of the notes offered by the preliminary pricing supplement hyperlinked below.

Summary of Terms

Upside Leverage Factor: At least 1.15*
Barrier Amount: With respect to each Fund, 70.00% of its Initial Value
Payment At Maturity: If the Final Value of each Fund is greater than its Initial Value, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Lesser Performing Fund Return} \times \text{Upside Leverage Factor})$$

If the Final Value of either Fund is equal to or less than its Initial Value but the Final Value of each Fund is greater than or equal to its Barrier Amount, you will receive the principal amount of your notes at maturity.

If the Final Value of either Fund is less than its Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + \$1,000 \times (\text{Lesser Performing Fund Return})$$

If the Final Value of either Fund is less than its Barrier Amount, you will lose more than 30.00% of your principal amount at maturity and could lose all of your principal amount at maturity.

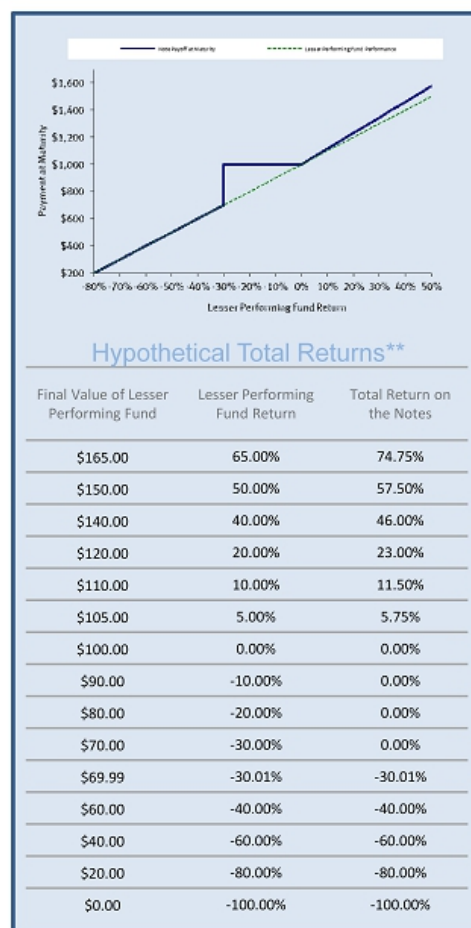
