## General

This supplemental term sheet relates to two (2) separate note offerings. Each issue of offered notes is linked to one, and only one, Reference Stock. ## Selected Purchase Considerations

- THE NOTES OFFER A HIGHER INTEREST RATE THAN THE YIELD ON DEBT SECURITIES OF COMPARABLE MATURITY ISSUED BY US OR AN ISSUER WITH A COMPARABLE CREDIT RATING - The notes will pay interest at an Interest Rate depending upon the applicable Reference Stock, as indicated on the cover of this supplemental term sheet. We believe that the applicable Interest Rate is higher than the yield received on debt securities of comparable maturity issued by us or an issuer with a comparable credit rating. Because the notes are our senior unsecured obligations, any interest payment or any payment at maturity is subject to our ability to pay our obligations as they become due.
- MONTHLY INTEREST PAYMENTS - The notes offer monthly interest payments at the applicable Interest Rate set forth on the cover of this supplemental term sheet. Interest will be payable monthly in arrears on the last calendar day of each month, except for the final interest payment, which shall be payable on the Maturity Date (each such date, an "Interest Payment Date"), commencing June 30, 2008, to and including the Interest Payment Date corresponding to the Maturity Date, to the holders of record at the close of business on the date 15 calendar days prior to the applicable Interest Payment Date. If an Interest Payment Date is not a business day, payment will be made on the next business day immediately following such day, but no additional interest will accrue as a result of the delayed payment.
- THE NOTES DO NOT GUARANTEE THE RETURN OF YOUR PRINCIPAL - Your return of principal at maturity is protected if the applicable Final Share Price does not decline from the applicable Initial Share Price or the closing price of the applicable Reference Stock does not decline, as compared to the applicable Initial Share Price, by more than the applicable Protection Amount on any day during the Monitoring Period. However, if the applicable Final Share Price declines from the applicable Initial Share Price and the closing price of the applicable Reference Stock on any day during the Monitoring Period has declined by more than the applicable Protection Amount, you could lose the entire principal amount of your notes.
- TAX TREATMENT AS A UNIT COMPRISING A PUT OPTION AND A DEPOSIT - You should review carefully the section entitled "Certain U.S. Federal Income Tax Consequences" in the accompanying product supplement no. $34-\mathrm{VI}$. We and you agree (in the absence of an administrative determination or judicial ruling to the contrary) to treat the notes as units comprising a Put Option and a Deposit for U.S. federal income tax purposes. We will determine the portion of each coupon payment that we will allocate to interest on the Deposit and to Put Premium, respectively, and will provide that allocation in the pricing supplement for the notes. If the notes had priced on May 5, 2008, of each coupon payment, we would have treated the percentages specified on the cover of this supplemental term sheet as interest on the Deposit and as Put Premium, respectively. The actual allocation that we will determine for the notes may differ from this hypothetical allocation, and will depend upon a variety of factors, including actual market conditions and our borrowing costs for debt instruments of comparable maturities on the Pricing Date. Assuming this characterization is respected, amounts treated as interest on the Deposit will be taxed as ordinary income while the Put Premium will not be taken into account prior to maturity or sale. However, there are other reasonable treatments that the Internal Revenue Service (the "IRS") or a court may adopt, in which case the timing and character of any income or loss on the notes could be significantly and adversely affected. - YOUR INVESTMENT IN THE NOTES MAY RESULT IN A LOSS - The notes do not guarantee any return of principal. The payment at maturity will be based on the applicable Final Share Price and whether the closing price of the applicable Reference Stock has declined
from the applicable Initial Share Price by more than the applicable Protection Amount on any day during the Monitoring Period. Under certain circumstances, you will receive at maturity a predetermined number of shares of the applicable Reference Stock (or, at our election, the Cash Value thereof). Because the Final Share Price of the Reference Stock is $\$ 60.80$, the total value of your final payment at maturity, whether in cash or shares of the Reference Stock, is $\$ 950.00$.

Example 3: The closing price of the Reference Stock does not decline, as compared with the Initial Share Price, by more than the Protection Amount on any day during the Monitoring Period prior to the Observation Date. However, the closing price of the Reference Stock on the Observation Date is $\$ 32.00$, a decline of more than the Protection Amount. Because the Final Share Price of $\$ 32.00$ is less than the Initial Share Price of $\$ 64.00$ and the Final Share Price has declined by more than the Protection Amount, you will receive the Physical Delivery Amount, or at our election, the Cash Value thereof, at maturity. Because the Final Share Price of the Reference Stock is $\$ 32.00$, the total value of your final payment at maturity, whether in cash or shares of the Reference Stock, is $\$ 500.00$.

Example 4: The Final Share Price of $\$ 51.20$ is less than the Initial Share Price of $\$ 64.00$ but does not decline by more than the Protection Amount and the closing price of the Reference Stock does not decline by more than the Protection Amount on any day during the Monitoring Period. Because the closing price of the Reference Stock has not declined by more than the Protection Amount, you will receive a payment at maturity of $\$ 1,000$ per $\$ 1,000$ principal amount note, even though the Final Share Price of $\$ 51.20$ is less than the Initial Share Price of $\$ 64.00$.

Regardless of the performance of the Reference Stock or the payment you receive at maturity, you will receive interest payments, for each $\$ 1,000$ principal amount note, in the aggregate amount of approximately $\$ 37.50$ over the term of the notes. Example 3: The closing price of the Reference Stock does not decline, as compared with the Initial Share Price, by more than the Protection Amount on any day during the Monitoring Period prior to the Observation Date. However, the closing price of the Reference Stock on the Observation Date is $\$ 58.00$, a decline of more than the Protection Amount. Because the Final Share Price of $\$ 58.00$ is less than the Initial Share Price of $\$ 116.00$ and the Final Share Price has declined by more than the Protection Amount, you will receive the Physical Delivery Amount, or at our election, the Cash Value thereof, at maturity. Because the Final Share Price of the Reference Stock is $\$ 58.00$, the total value of your final payment at maturity, whether in cash or shares of the Reference Stock, is $\$ 500.00$.

Example 4: The Final Share Price of $\$ 87.00$ is less than the Initial Share Price of $\$ 116.00$ but does not decline by more than the Protection Amount and the closing price of the Reference Stock does not decline by more than the Protection Amount on any day during the Monitoring Period. Because the closing price of the Reference Stock has not declined by more than the Protection Amount, you will receive a payment at maturity of $\$ 1,000$ per $\$ 1,000$ principal amount note, even though the Final Share Price of $\$ 87.00$ is less than the Initial Share Price of $\$ 116.00$.
