

## 3yr Partial Principal at Risk Capped Notes linked to INDU/NDX/RTY

## Summary of Terms

**Maximum Amount:** At least \$350.00 per \$1,000 principal amount note\*  
**Additional Amount:** \$1,000 × Least Performing Index Return × Participation Rate, provided that the Additional Amount will not be greater than the Maximum Amount

## Payment At Maturity:

If the Final Value of each Index is greater than its Initial Value, at maturity, you will receive a cash payment, for each \$1,000 principal amount note, of \$1,000 plus the Additional Amount, which will not be greater than the Maximum Amount.

If (i) the Final Value of one or more Indices is greater than its Initial Value and the Final Value of the other Index or Indices is equal to its Initial Value or (ii) the Final Value of each Index is equal to or less than its Initial Value, your payment at maturity will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Least Performing Index Return})$$

In no event however, will the payment at maturity be less than \$950.00 per \$1,000 principal amount note.

If the Final Value of any Index is less than its Initial Value, you will lose up to 5.00% of your principal amount at maturity.
