

## 5yr Uncapped Dual Directional Accelerated Barrier Notes linked to Least Performing of SPX/RTY/NDX

If the Final Value of any Index is equal to or less than its Initial Value but the Final Value of each

amount note will be calculated as follows:

1,000 + (\$1,000 × Absolute Index Return of the Least Performing Index)

This payout formula results in an effective cap of 30.00% on your return at maturity if the Least Performing Index Return is negative. Under these limited circumstances, your maximum payment at maturity is \$1,300.00 per \$1,000 principal amount note.

If the Final Value of any Index is less than its Barrier Amount, your payment at maturity per \$1,000

\$1,000 + (\$1,000 x Least Performing Index Return)


