

## 1.5yr Partial Principal at Risk Notes linked to SX5E

The following is a summary of the terms of the notes offered by the preliminary pricing supplement highlighted below.

## Summary of Terms

**Maximum Loss:** 10.00%  
**Additional Amount:** \$1,000 × Underlying Return × Participation Rate  
**Payment At Maturity:** If the Final Value is greater than the Initial Value, at maturity, you will receive a cash payment, for each \$1,000 principal amount note, of \$1,000 *plus* the Additional Amount.  
 If the Final Value is equal to or less than the Initial Value, your payment at maturity will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Underlying Return})$$

In no event, however, will the payment at maturity be less than \$900.00 per \$1,000 principal amount note.

*If the Final Value is less than the Initial Value, you will lose up to 10.00% of your principal amount at maturity.*

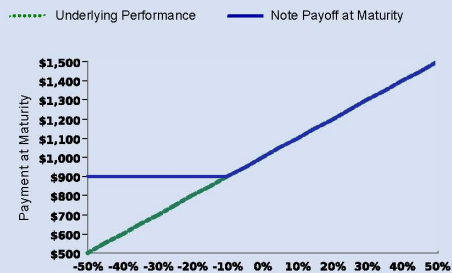

### Selected Risks
