

The following is a summary of the terms of the notes offered by the preliminary pricing supplement highlighted below.

Summary of Terms

Issuer: JPMorgan Chase Financial Company LLC
Guarantor: JPMorgan Chase & Co.
Minimum Denomination: \$1,000
Underlyings: Dow Jones Industrial Average™ and NASDAQ-100 Index®
Pricing Date: August 31, 2021
Observation Date: September 03, 2024
Maturity Date: September 06, 2024
Upside Leverage Factor: At least 1.00*
Barrier Amount: With respect to each Underlying, 75.00% of its Initial Value
Payment At Maturity: If the Final Value of the Lesser Performing Underlying is greater than its Initial Value, your payment at maturity per \$1,000 principal amount note will be calculated as follows:
$$\$1,000 + (\$1,000 \times \text{Lesser Performing Underlying Return} \times \text{Upside Leverage Factor})$$

If the Upside Leverage Factor is set at 1.00, you will not benefit from any upside leverage at maturity.
If the Final Value of either Underlying is equal to or less than its Initial Value but the Final Value of each Underlying is greater than or equal to its Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:
$$\$1,000 + (\$1,000 \times \text{Absolute Underlying Return of the Lesser Performing Underlying})$$

This payout formula results in an effective cap of 25.00% on your return at maturity if the Lesser Performing Underlying Return is negative. Under these limited circumstances, your maximum payment at maturity is \$1,250.00 per \$1,000 principal amount note.
If the Final Value of the Lesser Performing Underlying is less than its Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:
$$\$1,000 + (\$1,000 \times \text{Lesser Performing Underlying Return})$$

If the Final Value of the Lesser Performing Underlying is less than its Barrier Amount, you will lose more than 25.00% of your principal amount at maturity and could lose all of your principal amount at maturity.

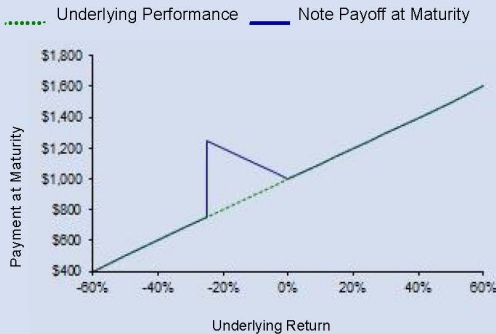
