



# JPMorgan Chase & Co. Trigger Autocallable Optimization Securities

Linked to the common stock of Corning Incorporated due on or about January 27, 2012

Linked to the common shares of Marvell Technology Group Ltd. due on or about January 27, 2012

## Investment Description

Trigger Autocallable Optimization Securities are unsecured and unsubordinated notes issued by JPMorgan Chase & Co. (“JPMorgan Chase”) (each a “Note” and collectively, the “Notes”) linked to the performance of the common stock of a specific company (the “Underlying Stock”). The Notes are designed for investors who believe that the price of the applicable Underlying Stock will remain flat or increase during the term of the Notes. If the applicable Underlying Stock closes at or above the applicable Initial Share Price (subject to adjustments, in the sole discretion of the calculation agent, in the case of certain corporate events described in the accompanying product supplement no. UBS-13-A-II under “General Terms of Notes — Anti-Dilution Adjustments”) on any Observation Date, JPMorgan Chase will automatically call the Notes and pay you a Call Price equal to the principal amount per Note plus a Call Return. The Call Return increases the longer the Notes are outstanding. If by maturity the Notes have not been called, JPMorgan Chase will either repay the full principal amount or, if the applicable Underlying Stock closes below the applicable Trigger Price on the Final Valuation Date, JPMorgan Chase will repay less than the principal amount, if anything, resulting in a loss that is proportionate to the decline in the price of the applicable Underlying Stock from the Trade Date to the Final Valuation Date. **Investing in the Notes involves significant risks. ## Hypothetical Examples

The examples below illustrate the hypothetical payment upon a call or at maturity under different hypothetical scenarios for a \$10.00 Note on an offering of the Notes linked to a hypothetical Underlying Stock, with the following assumptions (the actual terms for each Note will be determined on the Trade Date; amounts have been rounded for ease of reference):

Principal Amount:	\$10.00
Term:	Approximately 12 months (unless earlier called)
Initial Share Price:	\$20.00
Call Return Rate:	17.00%* per annum (or 1.417% per month)
Observation Dates:	Monthly
Trigger Price:	\$15.00 (which is 75.00% of the Initial Share Price)

\* The actual Call Return Rate for each Note will be set on the Trade Date and will be between 15.00% and 19.00% per annum for Notes linked to the common stock of Corning Incorporated and between 19.00% and 23.00% per annum for Notes linked to the common shares of Marvell Technology Group Ltd. ### Example 1 — Notes are Called on the First Observation Date

Closing Price at first Observation Date:	\$22.00 (at or above Initial Share Price, Notes are called)
Call Price (per Note):	\$10.147

Because the Notes are called on the first Observation Date, we will pay you on the Call Settlement Date a total Call Price of \$10.147 per \$10.00 principal amount (1.417% return on the Notes).

Closing Price at Final Valuation Date:	\$18.00 (below Initial Share Price, but above Trigger Price, Notes NOT called)
Settlement Amount (per Note):	\$10.00

Because the Notes are not called and the Final Share Price is above or equal to the Trigger Price, at maturity we will pay you a total of \$10.00 per \$10.00 principal amount (a zero return on the Notes).

Because the Notes are not called and the Final Share Price is below the Trigger Price, at maturity JPMorgan Chase will pay you a total of \$5.00 per \$10.00 principal amount (a 50% loss on the Notes).



## What Are the Tax Consequences of the Notes?

You should review carefully the section entitled “Certain U.S. Federal Income Tax Consequences” in the accompanying product supplement no. UBS-13-A-II. Subject to the limitations described therein, and based on certain factual representations received from us, in the opinion of our special tax counsel, Davis Polk & Wardwell LLP, it is reasonable to treat the Notes as “open transactions” for U.S. federal income tax purposes. ## Key Risks

**Supplemental Plan of Distribution**

We have agreed to indemnify UBS and JPMS against liabilities under the Securities Act of 1933, as amended, or to contribute to payments that UBS may be required to make relating to these liabilities as described in the prospectus supplement and the prospectus. We will agree that UBS may sell all or a part of the Notes that it purchases from us to its affiliates at the price indicated on the cover of the pricing supplement, the document that will be filed pursuant to Rule 424(b)(2) and containing the final pricing terms of the Notes.

Subject to regulatory constraints, JPMS intends to offer to purchase the Notes in the secondary market, but it is not required to do so.

We or our affiliate may enter into swap agreements or related hedge transactions with one of our other affiliates or unaffiliated counterparties in connection with the sale of the Notes, and JPMS and/or an affiliate may earn additional income as a result of payments pursuant to the swap or related hedge transactions.
