

18m SPX Trigger Participation Securities

This document provides a summary of the terms of the Trigger Participation Securities, which we refer to as the securities. Investors must carefully review the accompanying preliminary pricing supplement referenced below, product supplement, underlying supplement, prospectus supplement and prospectus and the “Risk Considerations” on the following page, prior to making an investment decision.

SUMMARY TERMS

Issuer: JPMorgan Chase Financial Company LLC (“JPMorgan Financial”)

Guarantor: JPMorgan Chase & Co.

Underlying index: S&P 500® Index (Bloomberg ticker: SPX Index)

Payment at maturity: If the final index value is greater than the initial index value, for each \$1,000 stated principal amount security:
\$1,000 + upside payment
Under these circumstances, in no event will the payment at maturity exceed the maximum payment at maturity.
If the final index value is less than or equal to the initial index value but is greater than or equal to the trigger level, for each \$1,000 stated principal amount security:
\$1,000
If the final index value is less than the trigger level, for each \$1,000 stated principal amount security:
\$1,000 × index performance factor

Maximum payment at maturity: At least \$1,196.00 (at least 119.60% of the stated principal amount) per security

Stated principal amount: \$1,000 per security

Issue price: \$1,000 per security

Pricing date: Expected to be February 16, 2024

Original issue date (settlement date): 3 business days after the pricing date

Maturity date†: August 21, 2025

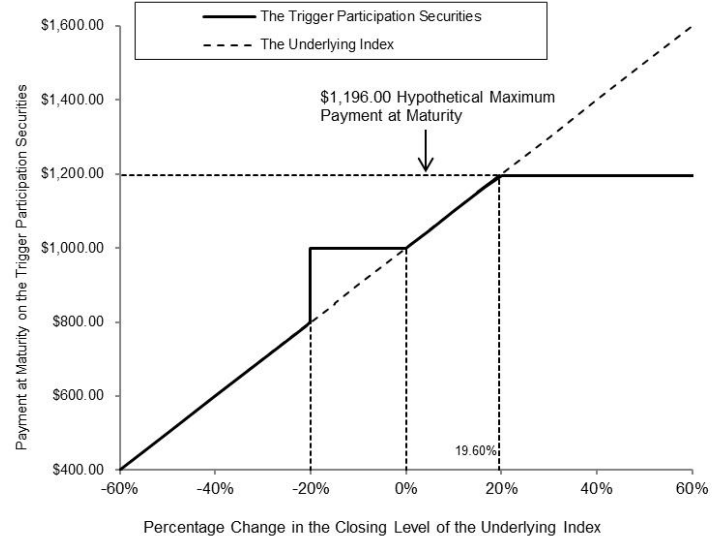
