General

Investors should be willing to forgo interest and dividend payments and, if the closing price of one share of the Reference Stock is less than the Initial Share Price by more than 20.00% on any day during the Monitoring Period, be willing to lose some or all of their principal. If the closing price of one share of the Reference Stock is not less than the Initial Share Price by more than 20.00% on any day during the Monitoring Period, investors have the opportunity to receive the greater of (a) the Share Return and (b) the Contingent Minimum Return of at least 10.05% at maturity. Any payment on the notes is subject to the credit risk of JPMorgan Chase & Co.

Hypothetical Examples of Amounts Payable at Maturity

The following examples illustrate how the total returns set forth in the table above are calculated.

Example 1: A Knock-Out Event has not occurred, and the closing price of one share of the Reference Stock increases from the Initial Share Price of \$26.00 to a Final Share Price of \$27.30. Because a Knock-Out Event has not occurred and the Share Return of 5% is less than the hypothetical Contingent Minimum Return of 10.05%, the investor receives a payment at maturity of \$1,100.50 per \$1,000 principal amount note.

Example 2: A Knock-Out Event has not occurred, and the closing price of one share of the Reference Stock decreases from the Initial Share Price of \$26.00 to a Final Share Price of \$24.70. Because a Knock-Out Event has not occurred and the Share Return of -5% is less than the hypothetical Contingent Minimum Return of 10.05%, the investor receives a payment at maturity of \$1,100.50 per \$1,000 principal amount note.

Example 3: A Knock-Out Event has not occurred, and the closing price of one share of the Reference Stock increases from the Initial Share Price of \$26.00 to a Final Share Price of \$29.90. Because a Knock-Out Event has not occurred and the Share Return of 15% is greater than the hypothetical Contingent Minimum Return of 10.05% but less than the hypothetical Maximum Return of 20.00%, the investor receives a payment at maturity of \$1,150 per \$1,000 principal amount note, calculated as follows:

⁽²⁾ The closing price of one share of the Reference Stock is less than \$20.80 (80% of the hypothetical Initial Share Price) on at least one day during the Monitoring Period.

Example 4: A Knock-Out Event has occurred, and the closing price of one share of the Reference Stock decreases from the Initial Share Price of \$26.00 to a Final Share Price of \$23.40. Because a Knock-Out Event has occurred and the Share Return is -10%, the investor receives a payment at maturity of \$900 per \$1,000 principal amount note, calculated as follows:

$$$1,000 + ($1,000 \times -10\%) = $900$$

Example 5: A Knock-Out Event has occurred, and the closing price of one share of the Reference Stock increases from the Initial Share Price of \$26.00 to a Final Share Price of \$29.90. Because a Knock-Out Event has occurred and the Share Return of 15% is less than the hypothetical Maximum Return of 20.00%, the investor receives a payment at maturity of \$1,150 per \$1,000 principal amount note, calculated as follows:

$$1,000 + (1,000 \times 15\%) = 1,150$$

Example 6: The closing price of one share of the Reference Stock increases from the Initial Share Price of \$26.00 to a Final Share Price of \$39.00. Because the Share Return of 50% is greater than the hypothetical Maximum Return of 20.00%, regardless of whether a Knock-Out Event has occurred, the investor receives a payment at maturity of \$1,200 per \$1,000 principal amount note, the hypothetical maximum payment on the notes.

These returns and payouts on the notes shown above do not reflect fees or expenses that would be associated with any sale in the secondary market. If these fees and expenses were included, the hypothetical total returns and payouts shown above would likely be lower.

Selected Purchase Considerations

- CAPPED APPRECIATION POTENTIAL The notes provide the opportunity to participate in the appreciation of the Reference Stock, up to the Maximum Return of at least 20.00% at maturity. If a Knock-Out Event has not occurred, in addition to the principal amount, you will receive at maturity at least the Contingent Minimum Return of not less than 10.05% on the notes, for a minimum payment at maturity of at least \$1,100.50 for every \$1,000 principal amount note, subject to the Maximum Return of at least 20.00%. Even if a Knock-Out Event has occurred, if the Final Share Price is greater than the Initial Share Price, in addition to the principal amount, you will receive at maturity a return on the notes equal to the Share Return, subject to the Maximum Return of at least 20.00%. The maximum payment at maturity will be at least \$1,200 per \$1,000 principal amount note, regardless of whether a Knock-Out Event has occurred. The actual Contingent Minimum Return and Maximum Return will be set on the pricing date and will not be less than 10.05% and 20.00%, respectively. Because the notes are our senior unsecured obligations, payment of any amount at maturity is subject to our ability to pay our obligations as they become due.
- **RETURN LINKED TO A SINGLE REFERENCE STOCK** The return on the notes is linked to the performance of a single Reference Stock, which is the ADSs of Vodafone. For additional information see "The Reference Stock" in this term sheet.
- CAPITAL GAINS TAX TREATMENT You should review carefully the section entitled "Certain U.S. Federal Income Tax Consequences" in the accompanying product supplement no. 195-A-I. Subject to the limitations described therein, and based on certain factual representations received from us, in the opinion of our special tax counsel, Davis Polk & Wardwell LLP, it is reasonable to treat the notes as "open transactions" for U.S. federal income tax purposes. Assuming this characterization is respected, the gain or loss on your notes should be treated as long-term capital gain or loss if you hold your notes for more than a year, whether or not you are an initial purchaser of notes at the issue price. However, the Internal Revenue Service (the "IRS") or a court may not respect this characterization or treatment of the notes, in which case the timing and character of any income or loss on the notes could be significantly and adversely affected. In addition, in 2007 Treasury and the IRS released a notice requesting comments on the U.S. federal income tax treatment of "prepaid forward contracts" and similar instruments, such as the notes. The notice focuses in particular on whether to require holders of these instruments to accrue income over the term of their investment. It also asks for comments on a number of related topics, including the character of income or loss with respect to these instruments; the relevance of factors such as the nature of the underlying property to which the instruments are linked; the degree, if any, to which income (including any mandated accruals) realized by Non-U.S. Holders should be subject to withholding tax; and whether these instruments are or should be subject to the "constructive ownership" regime, which very generally can operate to recharacterize certain long-term capital gain as ordinary income and impose an interest charge. While the notice requests comments on appropriate transition rules and effective dates, any Treasury regulations or other guidance promulgated after consideration of these issues could materially and adversely affect the tax consequences of an investment in the notes, possibly with retroactive effect. Both U.S. and Non-U.S. Holders should consult their tax advisers regarding the U.S. federal income tax consequences of an investment in the notes, including possible alternative treatments and the issues presented by this notice. Non-U.S. Holders should also note that they may be withheld upon at a rate of up to 30% unless they have submitted a properly completed IRS Form W-8BEN or otherwise satisfied the applicable documentation requirements.

• YOUR INVESTMENT IN THE NOTES MAY RESULT IN A LOSS — The notes do not guarantee any return of principal. The ADSs are issued pursuant to a deposit agreement, which sets forth the rights and responsibilities of the ADS depositary, Vodafone, and holders of the ADSs, which may be different from the rights of holders of the ordinary shares. For example, Vodafone may make distributions in respect of ordinary shares that are not passed on to the holders of its ADSs. Any such differences between the rights of holders of the ADSs and the rights of holders of the ordinary shares of Vodafone may be significant and may materially and adversely affect the value of the ADSs and, as a result, the notes.
- RISKS ASSOCIATED WITH NON-U.S. SECURITIES An investment in notes linked to the value of ADSs representing interests in the ordinary shares of Vodafone, which are issued by an English issuer, involves risks associated with the home country of Vodafone. The ADSs of Vodafone, which are quoted and traded in U.S. dollars on the NASDAQ Stock Market, may trade differently from the ordinary shares of Vodafone quoted and traded in British pounds sterling on the London Stock Exchange. 
