Barrier Amount: With respect to each Index, 80.00% of its Initial Value
Payment At Maturity: If the Final Value of any Index is greater than or equal to its Initial Value, your payment at maturity per \$1,000 principal amount note will be calculated as follows:
 $\$1,000 + (\$1,000 \times \text{greater of (a) Contingent Digital Return and (b) Least Performing Index Return})$
 If the Final Value of any Index is less than its Initial Value but the Final Value of each Index is greater than or equal to its Barrier Amount, you will receive the principal amount of your notes at maturity
 If the Final Value of any Index is less than its Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:
 $\$1,000 + \$1,000 \times (\text{Least Performing Index Return})$
If the Final Value of either Index is less than its Barrier Amount, you will lose more than 20.00% of your principal amount at maturity and could lose all of your principal amount at maturity.

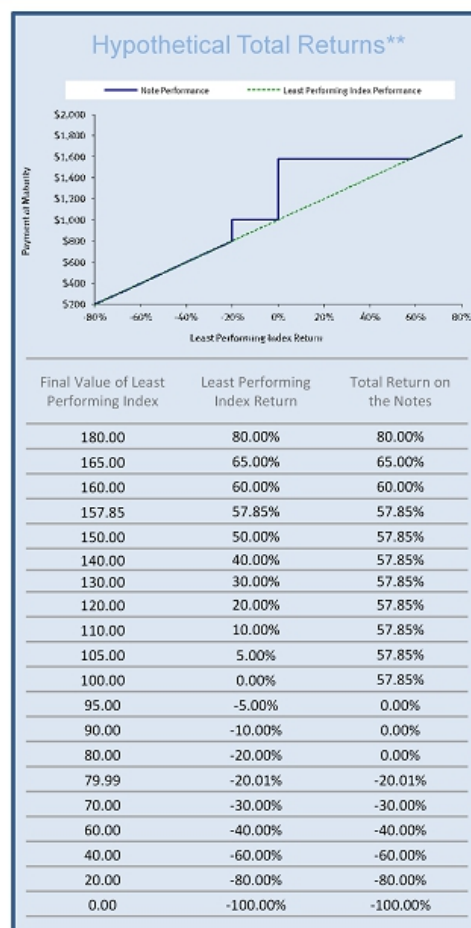
