Hypothetical Examples of Amount Payable at Maturity

The following examples illustrate how the payment at maturity is calculated under various hypothetical circumstances. You should review the following examples in conjunction with the hypothetical table set forth above, including the underlying assumptions described above. The hypothetical payments at maturity set forth below are for illustrative purposes only and may not be the actual payment at maturity applicable to a purchaser of the notes. The numbers appearing in the following examples have been rounded for ease of analysis.

Example 1: The level of the EURO STOXX 50° Index increases from a Initial Index Level of 4200 to an Ending Index Level of 4305, the FTSETM 100 Index increases from a Initial Index Level of 9600 to an Ending Index Level of 9696 and the level of the TOPIX[®] Index increases from a Initial Index Level of 10.8 to an Ending Index Level of 10.908.

Because the Ending Index Level of each Component Underlying is greater than its Initial Index Level, and the Underlying Returns of 2.50% for the EURO STOXX $50^{\text{®}}$ Index, 1.00% for the FTSETM 100 Index and 1.00% for the TOPIX[®] Index, each multiplied by 2, do not exceed the applicable Maximum Returns of 20.64%, 15.04% and 5.52%, respectively, the Basket Return is calculated as follows:

$$[(2.5\% \times 2) \times 51\%] + [(1\% \times 2) \times 25\%] + [(1\% \times 2) \times 24\%] = 3.530\%$$

Accordingly, the investor receives a payment at maturity of \$1,035.30 per \$1,000 principal amount note, calculated as follows:

$$1,000 + (1,000 \times 3.530\%) = 1,035.30$$

Example 2: The level of the EURO STOXX 50[®] Index increases from a Initial Index Level of 4200 to an Ending Index Level of 5040, the FTSE™ 100 Index increases from a Initial Index Level of 9600 to an Ending Index Level of 12480 and the level of the TOPIX[®] Index increases from a Initial Index Level of 10.8 to an Ending Index Level of 15.12.

Because the Ending Index Level of each Component Underlying is greater than its Initial Index Level, and the Underlying Returns of 20.00% for the EURO STOXX 50[®] Index, 30.00% for the FTSE™ 100 Index and 40.00% for the TOPIX[®] Index, each multiplied by 2, exceed the applicable Maximum Returns of 20.64%, 15.04% and 5.52%, respectively, the investor receives a payment at maturity of \$1,156.20 per \$1,000 principal amount note, which reflects the maximum payment at maturity.

Example 3: The level of the EURO STOXX 50[®] Index increases from a Initial Index Level of 4200 to an Ending Index Level of 5040, the FTSE™ 100 Index increases from a Initial Index Level of 9600 to an Ending Index Level of 9696 and the level of the TOPIX[®] Index increases from a Initial Index Level of 10.8 to an Ending Index Level of 10.908.

Because the Ending Index Level of each Component Underlying is greater than its Initial Index Level, and the Underlying Return of 20.00% for the EURO STOXX 50[®] Index multiplied by 2 exceeds the applicable Maximum Return of 20.64%, while the Underlying Returns of 1% for the FTSE™ 100 Index and 1% for the TOPIX[®] Index, each multiplied by 2, do not exceed the applicable Maximum Returns of 15.04% and 5.52%, respectively, the Basket Return is calculated as follows:

$$(20.64\% \times 51\%) + [(1\% \times 2) \times 25\%] + [(1\% \times 2) \times 24\%] = 11.506\%$$

Accordingly, the investor receives a payment at maturity of \$1,115.06 per \$1,000 principal amount note, calculated as follows:

$$$1,000 + ($1,000 \times 11.506\%) = $1,115.06$$

Example 4: The level of the EURO STOXX 50[®] Index decreases from a Initial Index Level of 4200 to an Ending Index Level of 3990, the FTSE™ 100 Index decreases from a Initial Index Level of 9600 to an Ending Index Level of 9120 and the level of the TOPIX[®] Index decreases from a Initial Index Level of 10.8 to an Ending Index Level of 10.26. Because the Ending Index Level of each Component Underlying is less than its Initial Index Level by not more than 10%, the investor receives a payment at maturity of \$1,000 per \$1,000 principal amount note.

Example 5: The level of the EURO STOXX $50^{\$}$ Index decreases from a Initial Index Level of 4200 to an Ending Index Level of 2940, the FTSETM 100 Index decreases from a Initial Index Level of 9600 to an Ending Index Level of 7680 and the level of the TOPIX^{\$} Index decreases from a Initial Index Level of 10.8 to an Ending Index Level of 6.48

Because the Ending Index Level of each Component Underlying is less than its Initial Index Level by more than 10%, the Basket Return is calculated as follows:

$$\{[(-30\% + 10\%) \times 1.1111] \times 51\%\} + \{[(-20\% + 10\%) \times 1.1111] \times 25\%\} + \{[(-40\% + 10\%) \times 1.1111] \times 24\%\} = -22.111\%$$

Accordingly, the investor receives a payment at maturity of \$778.89 per \$1,000 principal amount note, calculated as follows:

$$1,000 + (1,000 \times -22.111\%) = 778.89$$

Example 6: The level of the EURO STOXX $50^{\$}$ Index decreases from a Initial Index Level of 4200 to an Ending Index Level of 2940, the FTSETM 100 Index decreases from a Initial Index Level of 9600 to an Ending Index Level of 9120 and the level of the TOPIX^{\$} Index decreases from a Initial Index Level of 10.8 to an Ending Index Level of 6.48.

Because the Ending Index Level of the FTSE™ 100 Index is less than its Initial Index Level by not more than 10% and the Ending Index Level of each of the other Component Underlyings is less than its Initial Index Level by more than 10%, the Basket Return is calculated as follows:

$$\{[(-30\% + 10\%) \times 1.1111] \times 51\%\} + 0\% + \{[(-40\% + 10\%) \times 1.1111] \times 24\%\} = -19.333\%$$

Accordingly, the investor receives a payment at maturity of \$806.67 per \$1,000 principal amount note, calculated as follows:

Example 7: The level of the EURO STOXX 50[®] Index increases from a Initial Index Level of 4200 to an Ending Index Level of 4410, the FTSE™ 100 Index decreases from a Initial Index Level of 9600 to an Ending Index Level of 7680 and the level of the TOPIX[®] Index decreases from a Initial Index Level of 10.8 to an Ending Index Level of 6.48. Because the Ending Index Level of the EURO STOXX 50[®] Index is greater than its Initial Index Level, and the Underlying Return of 5% multiplied by 2 does not exceed the applicable Maximum Return of 20.64%, and the Ending Index Level of each of the other Component Underlyings is less than its Initial Index Level by more than 10%, the Basket Return is calculated as follows:

$$[(5\% \times 2) \times 51\%] + \{[(-20\% + 10\%) \times 1.1111] \times 25\%\} + \{[(-40\% + 10\%) \times 1.1111] \times 24\%\} = -5.678\%$$

Accordingly, the investor receives a payment at maturity of \$943.22 per \$1,000 principal amount note, calculated as follows:

$$1,000 + (1,000 \times -5.678\%) = 943.22$$

Hypothetical Examples of Index Return Calculations

The following examples illustrate how the Index Return for a Component Index is calculated in different hypothetical scenarios based on a range of performances of the closing level of the EURO STOXX 50[®] Index and the Exchange Rate for the EURO STOXX 50[®] Index. The examples below use the EURO STOXX 50[®] Index as the Component Index and assume that the hypothetical closing level of the EURO STOXX 50[®] Index on the pricing date is 3000, the hypothetical Exchange Rate for the EURO STOXX 50[®] Index on the pricing date is 1.40 and, therefore, the hypothetical Initial Index Level for EURO STOXX 50[®] Index is 4200. The examples below also assume that the Ending Index Level for the EURO STOXX 50[®] Index is based on the Adjusted Closing Level of the EURO STOXX 50[®] Index on a single date, which we refer to as the final Ending Averaging Date. The hypothetical Index Returns set forth below are for illustrative purposes only and may not be the actual Index Returns for the EURO STOXX 50[®] Index or for any other Component Index. The numbers appearing in the following examples have been rounded for ease of analysis.

Example 1: The closing level of the EURO STOXX 50[®] Index increases from 3000 on the pricing date to 3300 on the final Ending Averaging Date, and the Exchange Rate of the EURO STOXX 50[®] Index remains flat at 1.40 from the pricing date to the final Ending Averaging Date.

The Ending Index Level is equal to:

3300 x 1.40 = 4620

Because the Ending Index Level of 4620 is greater than the Initial Index Level of 4200, the Index Return is positive and is equal to 10%.

Example 2: The closing level of the EURO STOXX 50[®] Index remains flat at 3000 from the pricing date to the final Ending Averaging Date, and the Exchange Rate of the EURO STOXX 50[®] Index increases from 1.40 on the pricing date to 1.68 on the final Ending Averaging Date.

The Ending Index Level is equal to:

3000 x 1.68 = 5040

Because the Ending Index Level of 5040 is greater than the Initial Index Level of 4200, the Index Return is positive and is equal to 20%.

Example 3: The closing level of the EURO STOXX 50[®] Index increases from 3000 on the pricing date to 3300 on the final Ending Averaging Date, and the Exchange Rate of the EURO STOXX 50[®] Index increases from 1.40 on the pricing date to 1.68 on the final Ending Averaging Date.

The Ending Index Level is equal to:

3300 x 1.68 = 5544

Because the Ending Index Level of 5544 is greater than the Initial Index Level of 4200, the Index Return is positive and is equal to 32%, which is greater than the Maximum Return for the Basket Component linked to the EURO STOXX 50[®] Index and therefore the Component Return for this Basket Component will be limited to the Maximum Return for such Basket Component.

Example 4: The closing level of the EURO STOXX 50[®] Index increases from 3000 on the pricing date to 3300 on the final Ending Averaging Date, but the Exchange Rate of the EURO STOXX 50[®] Index decreases from 1.40 on the pricing date to 1.12 on the final Ending Averaging Date.

The Ending Index Level of the EURO STOXX 50® Index is equal to:

3300 x 1.12 = 3696

Even though the closing level of the EURO STOXX 50[®] Index has increased by 10%, because the Exchange Rate of the EURO STOXX 50[®] Index has decreased by 20%, the Ending Index Level of 3696 is less than the Initial Index Level of 4200, and the Index Return is negative and is equal to -12%

Example 5: The closing level of the EURO STOXX 50[®] Index decreases from 3000 on the pricing date to 2700 on the final Ending Averaging Date, but the Exchange Rate of the EURO STOXX 50[®] Index increases from 1.40 on the pricing date to 1.68 on the final Ending Averaging Date.

The Ending Index Level is equal to:

2700 x 1.68 = 4536

Even though the closing level of the EURO STOXX 50[®] Index has decreased by 10%, because the Exchange Rate of the EURO STOXX 50[®] Index has increased by 20%, the Ending Index Level of 4536 is greater than the Initial Index Level of 4200, and the Index Return is positive and is equal to 8%.

Example 6: The closing level of the EURO STOXX 50[®] Index decreases from 3000 on the pricing date to 2700 on the final Ending Averaging Date, and the Exchange Rate of the EURO STOXX 50[®] Index decreases from 1.40 on the pricing date to 1.12 on the final Ending Averaging Date.

The Ending Index Level is equal to:

2700 x 1.12 = 3024

Because the Ending Index Level of 3024 is less than the Initial Index Level of 4200, the Index Return is negative and is equal to -28%.

Example 7: The closing level of the EURO STOXX 50[®] Index remains flat at 3000 from the pricing date to the final Ending Averaging Date, and the Exchange Rate of the EURO STOXX 50[®] Index decreases from 1.40 on the pricing date to 1.12 on the final Ending Averaging Date.

The Ending Index Level is equal to:

3000 x 1.12 = 3360

Because the Ending Index Level of 3360 is less than the Initial Index Level of 4200, the Index Return is negative and is equal to -20%.

Example 8: The closing level of the EURO STOXX 50[®] Index decreases from 3000 on the pricing date to 2700 on the final Ending Averaging Date, and the Exchange Rate of the EURO STOXX 50[®] Index remains flat at 1.40 from the pricing date to the final Ending Averaging Date.

The Ending Index Level is equal to:

2700 x 1.40 = 3780

Because the Ending Index Level of 3780 is less than the Initial Index Level of 4200, the Index Return is negative and is equal to -10%.



- the extent of governmental surplus or deficit in the members nations of the European Union (including the United Kingdom), Japan and the United States.


All of these factors are, in turn, sensitive to the monetary, fiscal and trade policies pursued by the European Union (including the United Kingdom and other members countries), Japan, the United States and those of other countries important to international trade and finance.


- THE RECENT GLOBAL FINANCIAL CRISIS CAN BE EXPECTED TO HEIGHTEN CURRENCY EXCHANGE RISKS In periods of financial turmoil, capital can move quickly out of regions that are perceived to be more vulnerable to the effects of the crisis than others with sudden and severely adverse consequences to the currencies of those regions. In addition, governments around the world, including the United States government and governments of other major world currencies, have recently made, and may be expected to continue to make, very significant interventions in their economies, and sometimes directly in their currencies. Such interventions affect currency exchange rates globally and, in particular, the value of the Component Currencies relative to the U.S. dollar. Further interventions, other government actions or suspensions of actions, as well as other changes in government economic policy or other financial or economic events affecting the currency markets, may cause currency exchange rates to fluctuate sharply in the future, which could have a material adverse effect on the value of the notes and your return on your investment in the notes at maturity.
- NO INTEREST OR DIVIDEND PAYMENTS OR VOTING RIGHTS As a holder of the notes, you will not receive interest payments, and










The next three graphs below show the historical weekly performance of each Component Currency expressed in terms of the conventional market quotation (which, in the case of the European Union Euro (EUR) and the British Pound Sterling (GBP) is the amount of U.S. Dollars that can be exchanged for one European Union Euro and one British Pound Sterling, respectively, and, in the case of the Japanese Yen (JPY), is the amount of the Japanese Yen that can be exchanged for one U.S. Dollar), as shown on Bloomberg Financial Markets, from January 6, 2006 through January 28, 2011. The exchange rates of the European Union Euro, the British Pound Sterling and the Japanese Yen on January 31, 2011 were 1.3694, 1.6014 and 82.04, respectively.

The exchange rates set forth above and displayed in the graphs below are for illustrative purposes only and do not form part of the calculation of the Basket Return. The value of the Basket, and thus the Basket Return, assuming no change in the closing levels of the Component Indices, increases when the U.S. dollar depreciates in value against the individual Component Currencies. Therefore, the Index Return for each Component Index and, consequently, the Basket Return, is calculated using the Exchange Rates for each Component Currency expressed, for the European Union Euro and the British Pound Sterling, as the amount of U.S. Dollars per one unit of the applicable Component Currency, which is largely consistent with the approach used to determine the conventional market quotation for each such Component Currency set forth above and in the applicable graphs below and, for the Japanese Yen, as one divided by the amount of the applicable Component Currency per one U.S. Dollar, which is the inverse of the conventional market quotation for each such Component Currency set forth above and in the applicable graph below. 



