Principal Amount:	\$1,000 per security (100% of par)
Contingent Coupon Payment:	On each contingent coupon payment date, you will receive a contingent coupon payment at a per annum rate equal to the contingent coupon rate if, and only if , the stock closing price of the Underlying Stock on the related calculation day is greater than or equal to the threshold price. Each “contingent coupon payment,” if any, will be calculated per security as follows: $(\$1,000 \times \text{contingent coupon rate}) / 12$
Contingent Coupon Payment Dates ^{1, 2} :	Monthly, on the third business day following each calculation day, <i>provided</i> that the contingent coupon payment date with respect to the final calculation day will be the stated maturity date
Contingent Coupon Rate:	At least 20.25% per annum (to be provided in the pricing supplement)
Automatic Call:	If the stock closing price of the Underlying Stock on either of the call dates from June 2024 to September 2024, inclusive, is greater than or equal to the starting price, the securities will be automatically called, and on the related call settlement date you will be entitled to receive a cash payment per security in U.S. dollars equal to the principal amount per security <i>plus</i> a final contingent coupon payment.
Calculation Days ^{1, 2} :	Monthly, on the 15th day of each month, commencing January 2024 and ending December 2024, <i>provided</i> that the December 2024 calculation day will be December 16, 2024. We refer to December 16, 2024 as the “ <u>final calculation day</u> .”
Call Dates ^{1, 2} :	Quarterly, on the calculation dates occurring in June 2024 and September 2024
Call Settlement Date ^{1, 2} :	Three business days after the applicable call date
Maturity Payment Amount (per security):	If the securities are not automatically called: · If the ending price is greater than or equal to the threshold price: \$1,000; or · If the ending price is less than the threshold price: $\$1,000 + (\$1,000 \times \text{stock return})$
Starting Price:	The stock closing price of the Underlying Stock on the pricing date
Ending Price:	The stock closing price of the Underlying Stock on the final calculation day
Stock Return:	$(\text{ending price} - \text{starting price}) / \text{starting price}$
Threshold Price:	50% of the starting price
Calculation Agent:	J.P. Morgan Securities LLC (“JPMS”)
Denominations:	\$1,000 and any integral multiple of \$1,000
CUSIP:	48134RU97

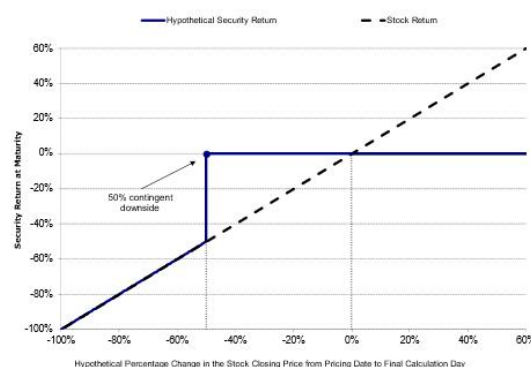

Fees and Commissions:	Up to 1.325% for Wells Fargo Securities, LLC (“WFS”); WFS has advised us that dealers, including Wells Fargo Advisors (“WFA”), may receive 0.75% of WFS’s fee, and WFA may also receive a distribution expense fee of 0.075%. If the securities are not automatically called prior to maturity and the ending price is less than the threshold price, you will lose more than 50%, and possibly all, of the principal amount of your securities at maturity.

Any return on the securities will be limited to the sum of your contingent coupon payments, if any. You will not participate in any appreciation of the Underlying Stock, but you will have full downside exposure to the Underlying Stock on the final calculation day if the ending price is less than the threshold price.
