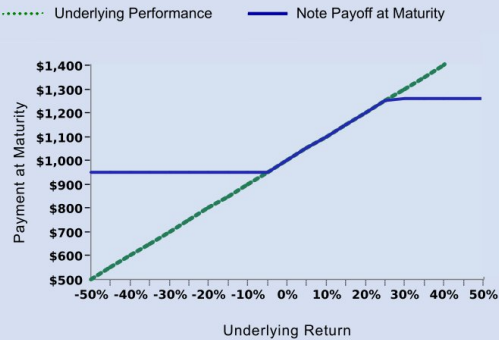

### Selected Risks
