

# 2.5y EFA Capped Dual Directional Accelerated Barrier Notes

The following is a summary of the terms of the notes offered by the preliminary pricing supplement hyperlinked below.

### Summary of Terms

Payment At Maturity: If the Final Value is greater than the Initial Value, your payment at maturity per \$1,000 principal

\$1,000 + (\$1,000 × Fund Return × Upside Leverage Factor), subject to the Maximum Return If the Final Value is equal to the Initial Value or is less than the Initial Value but greater than or equal to the Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated

\$1,000 + (\$1,000 × Absolute Fund Return)

This payout formula results in an effective cap of 25.00% on your return at maturity if the Fund m is negative. Under these limited circumstances, your maximum payment at maturity is \$1,250.00 per \$1,000 principal amount note.

If the Final Value is less than the Barrier Amount, your payment at maturity per \$1,000 principal

amount note will be calculated as follows:

\$1,000 + (\$1,000 × Fund Return)

If the Final Value is less than the Barrier Amount, you will lose more than 25.00% of your principal

amount at maturity and could lose all of your principal amount at maturity


