

6yr SX5E Uncapped Dual Directional Accelerated Barrier Notes

The following is a summary of the terms of the notes offered by the preliminary pricing supplement highlighted below.

Summary of Terms

Minimum Denomination: \$1,000
Underlying: EURO STOXX 50® Index
Pricing Date: November 18, 2022
Observation Date: November 20, 2028
Maturity Date: November 24, 2028
Upside Leverage Factor: At least 1.625*
Barrier Amount: 60.00% of the Initial Value
Payment At Maturity: If the Final Value is greater than the Initial Value, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Underlying Return} \times \text{Upside Leverage Factor})$$

If the Final Value is equal to or less than the Initial Value but greater than or equal to the Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Absolute Underlying Return})$$

This payout formula results in an effective cap of 40.00% on your return at maturity if the Underlying Return is negative. Under these limited circumstances, your maximum payment at maturity is \$1,400.00 per \$1,000 principal amount note.

If the Final Value is less than the Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Underlying Return})$$

If the Final Value is less than the Barrier Amount, you will lose more than 40.00% of your principal amount at maturity and could lose all of your principal amount at maturity.

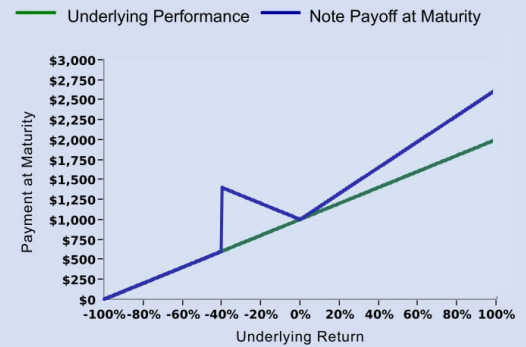
