The S&P 500® Index consists of 500 component stocks selected to provide a performance benchmark for the U.S. equity markets. under the notes through one or more of our affiliates. As a result, the price, if any, at which JPMSI will be willing to purchase notes from you in secondary market transactions, will likely be lower than the original issue price, and any sale prior to the maturity date could result in a substantial loss to you. The notes are not designed to be short-term trading instruments. Accordingly, you should be able and willing to hold your notes to maturity.

- NO INTEREST OR DIVIDEND PAYMENTS OR VOTING RIGHTS As a holder of the notes, you will not receive interest payments, and you will not have voting rights or rights to receive cash dividends or other distributions or other rights that holders of securities composing the S&P 500<sup>®</sup> Index would have.

The hypothetical total returns set forth below assume an Initial Index Level of 1450 and a Maximum Total Return on the notes of 15%. Hypothetical Examples of Amounts Payable at Maturity

The following examples illustrate how the total returns set forth in the table above are calculated.

#### Example 1: The level of the Index increases from the Initial Index Level of 1450 to an Ending Index Level of 1522.50.

Because the Ending Index Level of 1522.50 is greater than the Initial Index Level of 1450 and the Index Return of 5% multiplied by 2 does not exceed the hypothetical Maximum Total Return of 15%, the investor receives a payment at maturity of \$1,100 per \$1,000 principal amount note, calculated as follows:

$$1,000 + [1,000 \times (5\% \times 2)] = 1,100$$

### Example 2: The level of the Index increases from the Initial Index Level of 1450 to an Ending Index Level of 1667.50.

Because the Index Return of 15% multiplied by 2 exceeds the hypothetical Maximum Total Return of 15%, the investor receives a payment at maturity of \$1,150 per \$1,000 principal amount note, the maximum payment on the notes.

## Example 3: The level of the Index decreases from the Initial Index Level of 1450 to an Ending Index Level of 1160.

Because the Ending Index Level of 1160 is less than the Initial Index Level of 1450, the Index Return is negative and the investor receives a payment at maturity of \$800 per \$1,000 principal amount note, calculated as follows:

$$1,000 + (1,000 \times -20\%) = 800$$
