#### What Is the Total Return on the Notes at Maturity Assuming a Range of Performance for the Index?



Hypothetical Examples of Amounts Payable at Maturity

The following examples illustrate how the total returns set forth in the table and graph above are calculated.

**Example 1: The level of the Index increases from the Initial Index Level of 4300 to an Ending Index Level of 4515.** Because the Ending Index Level of 4515 is greater than the Initial Index Level of 4300 and the Index Return of 5% multiplied by 2 does not exceed the hypothetical Maximum Total Return of 18.80%, the investor receives a payment at maturity of \$1,100 per \$1,000 principal amount note, calculated as follows:

\$1,000 + [\$1,000 x (5% x 2)] = \$1,100

**Example 2: The level of the Index decreases from the Initial Index Level of 4300 to an Ending Index Level of 3870.** Because the Ending Index Level of 3870 is less than the Initial Index Level of 4300 by not more than the Buffer Amount of 10%, the investor will receive a payment at maturity of \$1,000 per \$1,000 principal amount note.

**Example 3: The level of the Index increases from the Initial Index Level of 4300 to an Ending Index Level of 5375.** Because the Ending Index Level of 5375 is greater than the Initial Index Level of 4300 and the Index Return of 25% multiplied by 2 exceeds the hypothetical Maximum Total Return of 18.80%, the investor receives a payment at maturity of \$1,188 per \$1,000 principal amount note, the maximum payment on the notes.

**Example 4: The level of the Index decreases from the Initial Index Level of 4300 to an Ending Index Level of 3440.** Because the Ending Index Level of 3440 is less than the Initial Index Level of 4300 by more than the Buffer Amount of 10%, the Index Return is negative and the investor receives a payment at maturity of \$888.89 per \$1,000 principal amount note, calculated as follows:

\$1,000 + [\$1,000 x (-20% + 10%) x 1.1111] = \$888.89

**Selected Purchase Considerations**

The actual Maximum Total Return on the notes will be set on the pricing date and will not be less than 18.80%. Because the notes are our senior unsecured obligations, payment of any amount at maturity is subject to our ability to pay our obligations as they become due.
- LIMITED PROTECTION AGAINST LOSS Payment at maturity of the principal amount of the notes is protected against a decline in the Ending Index Level, as compared to the Initial Index Level, of up to 10%. If the Ending Index Level declines by more than 10%, for every 1% decline of the Index beyond 10%, you will lose an amount equal to 1.1111% of the principal amount of your notes.

#### Selected Risk Considerations


- YOUR INVESTMENT IN THE NOTES MAY RESULT IN A LOSS The notes do not guarantee any return of principal. The return on the notes at maturity is linked to the performance of the Index and will depend on whether, and the extent to which, the Index Return is positive or negative. Your investment will be exposed on a leveraged basis to any decline in the Ending Index Level beyond the 10% buffer as compared to the Initial Index Level.
- YOUR MAXIMUM GAIN ON THE NOTES IS LIMITED TO THE MAXIMUM TOTAL RETURN If the Ending Index Level is greater than
  the Initial Index Level, for each \$1,000 principal amount note, you will receive at maturity \$1,000 plus an additional amount that will not
  exceed a predetermined percentage of the principal amount, regardless of the appreciation in the Index, which may be significant. We refer
  to this percentage as the Maximum Total Return, which will be set on the pricing date and will not be less than 18.80%.

  any currency fluctuations could affect the performance of the Index. Therefore, if the applicable currencies appreciate or depreciate relative

- NO INTEREST OR DIVIDEND PAYMENTS OR VOTING RIGHTS As a holder of the notes, you will not receive interest payments, and you will not have voting rights or rights to receive cash dividends or other distributions or other rights that holders of securities composing the Dow Jones EURO STOXX 50<sup>®</sup> Index would have.
