

## 18m RTY/SPX Capped Dual Directional Buffered Equity Notes

This payout formula results in an effective cap of 10.00% on your return at maturity if the Lessen Performing Underlying Return is negative. Under these limited circumstances, your maximum payment at maturity is \$1,100.00 per \$1,000 principal amount note.

If the Final Value of either Underlying is less than its Initial Value by more than the Buffer Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

\$1,000 + [\$1,000 x (Lesser Performing Underlying Return + Buffer Amount)]

If the Final Value of either Underlying is less than its Initial Value by more than the Buffer Amount, you will lose some or most of your principal amount at maturity.


