

5yr Uncapped Dual Directional Contingent Buffered Return Enhanced Notes linked to Least Performing of SPX/RTY/INDU

The following is a summary of the terms of the notes offered by the preliminary pricing supplement highlighted below.

Payment At Maturity: If the Final Value of each Index is greater than its Initial Value, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Least Performing Index Return} \times \text{Upside Leverage Factor})$$

If (i) the Final Value of one or more Indices is greater than its Initial Value and the Final Value of the other Index or Indices is equal to its Initial Value or is less than its Initial Value by up to the Contingent Buffer Amount or (ii) the Final Value of each Index is equal to its Initial Value or is less than its Initial Value by up to the Contingent Buffer Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$1,000 + (\$1,000 \times \text{Absolute Index Return of the Least Performing Index})$$

If the Final Value of any Index is less than its Initial Value by more than the Contingent Buffer Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Least Performing Index Return})$$

If the Final Value of any Index is less than its Initial Value by more than the Contingent Buffer Amount, you will lose more than 30.00% of your principal amount at maturity and could lose all of your principal amount at maturity.

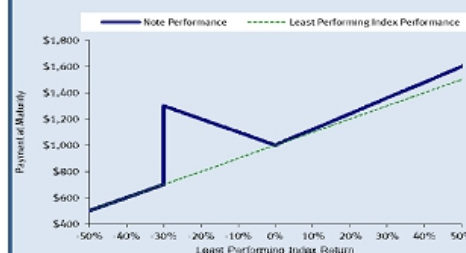
