

## 3yr Partial Principal at Risk Capped INDU Notes

## Summary of Terms

**Maturity Date:** June 4, 2026  
**Participation Rate:** 100.00%\*  
**Maximum Amount:** At least \$350.00 per \$1,000 principal amount note  
**Additional Amount:** \$1,000 × Index Return × Participation Rate, *provided that the Additional Amount will not be greater than the Maximum Amount*

## Payment At Maturity:

If the Final Value is greater than the Initial Value, at maturity, you will receive a cash payment, for each \$1,000 principal amount note, of \$1,000 *plus* the Additional Amount, which will not be greater than the Maximum Amount.

If the Final Value is equal to or less than the Initial Value, your payment at maturity will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Index Return})$$

In no event, however, will the payment at maturity be less than \$950.00 per \$1,000 principal amount note.

*If the Final Value is less than the Initial Value, you will lose up to 5.00% of your principal amount at maturity.*

*You are entitled to repayment of at least \$950.00 per \$1,000 principal amount note at maturity, subject to the credit risks of JPMorgan Financial and JPMorgan Chase & Co.*

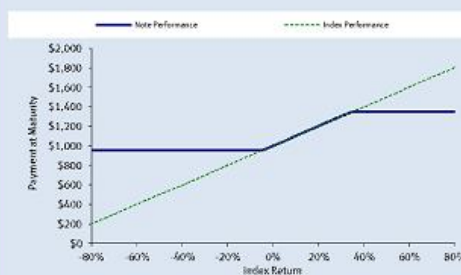

## Selected Risks
