

## 3yr Capped Dual Directional Barrier Notes linked to Least Performing of SPX/RTY/INDU

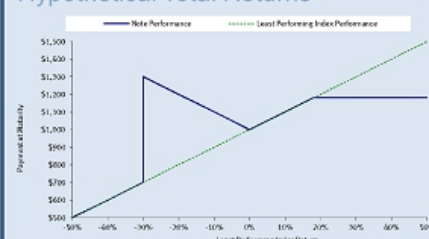
