- CAPPED APPRECIATION POTENTIAL - The notes provide the opportunity to enhance equity returns by multiplying a positive Index Return by 2 , up to the Maximum Return. The actual Maximum Return will be set on the pricing date and will not be less than $19.00 \%$ or greater than $23.00 \%$. Accordingly, the actual maximum payment at maturity will not be less than $\$ 1,190$ or greater than $\$ 1,230$ per $\$ 1,000$ principal amount note. Because the notes are our senior unsecured obligations, payment of any amount at maturity is subject to our ability to pay our obligations as they become due.
- LIMITED PROTECTION AGAINST LOSS - We will pay you your principal back at maturity if the Ending Index Level is not less than the Initial Index Level by more than 10\%. If the Ending Index Level is less than the Initial Index Level by more than 10\%, for every $1 \%$ that the Ending Index Level is less than the Initial Index Level by more than $10 \%$, you will lose an amount equal to $1 \%$ of the principal amount of your notes.
- RETURN LINKED TO THE RUSSELL $2000^{\circledR}$ INDEX — The return on the notes is linked to the performance of the Russell $2000^{\circledR}$ Index. Based on current market conditions, in the opinion of our special tax counsel it is reasonable to treat the notes as "open transactions" that are not debt instruments for U.S. federal income tax purposes. Assuming this treatment is respected, the gain or loss on your notes should be treated as long-term capital gain or loss if you hold your notes for more than a year, whether or not you are an initial purchaser of notes at the issue price. However, the Internal Revenue Service (the "IRS") or a court may not respect this treatment of the notes, in which case the timing and character of any income or loss on the notes could be significantly and adversely affected. In addition, in 2007 Treasury and the IRS released a notice requesting comments on the U.S. federal income tax treatment of "prepaid forward contracts" and similar instruments, such as the notes. The notice focuses in particular on whether to require holders of these instruments to accrue income over the term of their investment. - YOUR INVESTMENT IN THE NOTES MAY RESULT IN A LOSS - The notes do not guarantee any return of principal. The return on the notes at maturity is linked to the performance of the Index and will depend on whether, and the extent to which, the Index Return is positive or negative. Your investment will be exposed to loss if the Ending Index Level is less than the Initial Index Level by more than $10 \%$. For every 1\% that the Ending Index Level is less than the Initial Index Level by more than 10\%, you will lose an amount equal to $1 \%$ of the principal amount of your notes. Accordingly, you could lose up to $90 \%$ of your initial investment at maturity.
- YOUR MAXIMUM GAIN ON THE NOTES IS LIMITED TO THE MAXIMUM RETURN - If the Ending Index Level is greater than the Initial Index Level, for each \$1,000 principal amount note, you will receive at maturity $\$ 1,000$ plus an additional return that will not exceed a predetermined percentage of the principal amount, regardless of the appreciation in the Index, which may be significant. It is possible that hedging or trading activities of ours or our affiliates could result in substantial returns for us or our affiliates while the value of the notes declines. - AN INVESTMENT IN THE NOTES IS SUBJECT TO RISKS ASSOCIATED WITH SMALL CAPITALIZATION STOCKS — The stocks that constitute the Russell $2000^{\circledR}$ Index are issued by companies with relatively small market capitalization. The stock prices of smaller companies may be more volatile than stock prices of large capitalization companies. Small capitalization companies may be less able to withstand adverse economic, market, trade and competitive conditions relative to larger companies. Small capitalization companies are less likely to pay dividends on their stocks, and the presence of a dividend payment could be a factor that limits downward stock price pressure under adverse market conditions.

As a result, and as a general matter, the price, if any, at which JPMS will be willing to purchase notes from you in secondary market transactions, if at all, will likely be lower than the original issue price and any sale prior to the maturity date could result in a substantial loss to you. This secondary market price will also be affected by a number of factors aside from the agent's commission and hedging costs, including those set forth under "Many Economic and Market Factors Will Impact the Value of the Notes" below. The notes are not designed to be short-term trading instruments. Accordingly, you should be able and willing to hold your notes to maturity.
- NO INTEREST OR DIVIDEND PAYMENTS OR VOTING RIGHTS - As a holder of the notes, you will not receive interest payments, and you will not have voting rights or rights to receive cash dividends or other distributions or other rights that holders of securities composing the Index would have.
- LACK OF LIQUIDITY - The notes will not be listed on any securities exchange. JPMS intends to offer to purchase the notes in the secondary market but is not required to do so. Even if there is a secondary market, it may not provide enough liquidity to allow you to trade or sell the notes easily. Because other dealers are not likely to make a secondary market for the notes, the price at which you may be able to trade your notes is likely to depend on the price, if any, at which JPMS is willing to buy the notes.
- MANY ECONOMIC AND MARKET FACTORS WILL IMPACT THE VALUE OF THE NOTES - In addition to the level of the Index on any day, the value of the notes will be affected by a number of economic and market factors that may either offset or magnify each other, including:
- the actual and expected volatility of the Index;
- the time to maturity of the notes;
- the dividend rates on the equity securities underlying the Index;
- interest and yield rates in the market generally;
- a variety of economic, financial, political, regulatory and judicial events; and
- our creditworthiness, including actual or anticipated downgrades in our credit ratings.

The following table, graph and examples illustrate the hypothetical total return at maturity on the notes. The "total return" as used in this term sheet is the number, expressed as a percentage, that results from comparing the payment at maturity per $\$ 1,000$ principal amount note to $\$ 1,000$. The hypothetical total returns set forth below assume an Initial Index Level of 810 and a Maximum Return of 19.00\%. The actual Maximum Return will be determined on the pricing date and will not be less than $19.00 \%$ or greater than $23.00 \%$. The hypothetical total returns set forth below are for illustrative purposes only and may not be the actual total returns applicable to a purchaser of the notes. The following examples illustrate how the total returns set forth in the table above are calculated.
Example 1: The level of the Index increases from the Initial Index Level of $\mathbf{8 1 0}$ to an Ending Index Level of 850.50. Because the Ending Index Level of 850.50 is greater than the Initial Index Level of 810 and the Index Return of $5 \%$ multiplied by 2 does not exceed the Maximum Return of $19.00 \%$, the investor receives a payment at maturity of $\$ 1,100$ per $\$ 1,000$ principal amount note, calculated as follows:

$$
\$ 1,000+[\$ 1,000 \times(5 \% \times 2)]=\$ 1,100
$$

Example 2: The level of the Index decreases from the Initial Index Level of $\mathbf{8 1 0}$ to an Ending Index Level of 769.50. Although the Index Return is negative, because the Ending Index Level of 769.50 is less than the Initial Index Level of 810 by not more than the Buffer Amount of $10 \%$, the investor receives a payment at maturity of $\$ 1,000$ per $\$ 1,000$ principal amount note.
Example 3: The level of the Index increases from the Initial Index Level of $\mathbf{8 1 0}$ to an Ending Index Level of 1,053. Because the Ending Index Level of 1,053 is greater than the Initial Index Level of 810 and the Index Return of $30 \%$ multiplied by 2 exceeds the Maximum Return of $19.00 \%$, the investor receives a payment at maturity of $\$ 1,190.00$ per $\$ 1,000$ principal amount note, the maximum payment on the notes.
Example 4: The level of the Index decreases from the Initial Index Level of $\mathbf{8 1 0}$ to an Ending Index Level of 567. Because the Index Return is negative and the Ending Index Level of 567 is less than the Initial Index Level of 810 by more than the Buffer Amount of $10 \%$, the investor receives a payment at maturity of $\$ 800$ per $\$ 1,000$ principal amount note, calculated as follows:

$$
\$ 1,000+[\$ 1,000 \times(-30 \%+10 \%)]=\$ 800
$$

Example 5: The level of the Index decreases from the Initial Index Level of $\mathbf{8 1 0}$ to an Ending Index Level of 0.00. Because the Index Return is negative and the Ending Index Level of 0.00 is less than the Initial Index Level of 810 by more than the Buffer Amount of 10\%, the investor receives a payment at maturity of $\$ 100$ per $\$ 1,000$ principal amount note, calculated as follows:

$$
\$ 1,000+[\$ 1,000 \times(-100 \%+10 \%)]=\$ 100
$$
