

## 3yr GILD Contingent Income Auto-Callable Securities

**This document provides a summary of the terms of the securities. ## SUMMARY OF TERMS

<b>Issuer:</b>	JPMorgan Chase Financial Company LLC ("JPMorgan Financial")
<b>Guarantor:</b>	JPMorgan Chase & Co.
<b>Underlying stock:</b>	Common stock of Gilead Sciences, Inc. (Bloomberg ticker: GILD UW Equity)
<b>Early redemption:</b>	If, on any determination date (other than the final determination date), the closing price of the underlying stock is <b>greater than or equal to</b> the initial stock price, the securities will be automatically redeemed for an early redemption payment on the first contingent payment date immediately following the related determination date. No further payments will be made on the securities once they have been redeemed. <b>The securities will not be redeemed early on any contingent payment date if the closing price of the underlying stock is below the initial stock price on the related determination date.</b>
<b>Early Redemption payment:</b>	The early redemption payment will be an amount equal to (i) the stated principal amount <b>plus</b> (ii) the contingent quarterly payment with respect to the related determination date.
