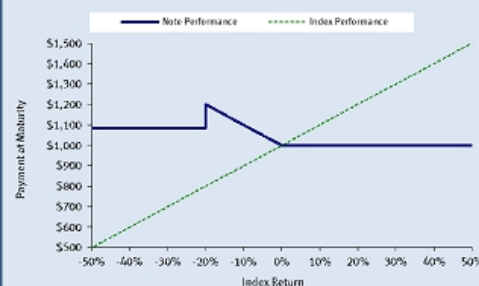

Selected Risks
