

# 5yr INDU/NDX/RTY Uncapped Dual Directional Digital Barrier Notes

### Summary of Terms

Payment At Maturity: If the Final Value of each Index is greater than or equal to its Initial Value, your payment at maturity

\$1,000 + (\$1,000 × greater of (a) the Contingent Digital Return and (b) the Least Performing

Index Return)

If the Final Value of any Index is less than its Initial Value but the Final Value of each Index is greater than or equal to its Barrier Amount, your payment at maturity per \$1,000 principal amount

note will be calculated as follows:

\$1,000 + (\$1,000 × Absolute Index Return of the Least Performing Index)

This payout formula results in an effective cap of 40.00% on your return at maturity if the Least Performing Index Return is negative. Under these limited circumstances, your maximum payment at maturity is \$1,400.00 per \$1,000 principal amount note.

If the Final Value of any Index is less than its Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

\$1,000 + (\$1,000 x Least Performing Index Return)

If the Final Value of any Index is less than its Barrier Amount, you will lose more than 40.00% of your principal amount at maturity and could lose all of your principal amount at maturity.


