

## 18m SPX Capped Dual Directional Buffered Return Enhanced Notes

The following is a summary of the terms of the notes offered by the preliminary pricing supplement hyperlinked below.

## Summary of Terms

**Issuer:** JPMorgan Chase Financial Company LLC  
**Guarantor:** JPMorgan Chase & Co.  
**Minimum Denomination:** \$1,000  
**Index:** S&P 500® Index  
**Pricing Date:** April 4, 2023  
**Observation Date:** October 4, 2024  
**Maturity Date:** October 9, 2024  
**Maximum Upside Return:** At least 15.50%\*  
**Upside Leverage Factor:** 1.50  
**Buffer Amount:** 15.00%  
**Payment At Maturity:** If the Final Value is greater than the Initial Value, your payment at maturity per \$1,000 principal amount note will be calculated as follows:  

$$\$1,000 + (\$1,000 \times \text{Index Return} \times \text{Upside Leverage Factor}), \text{ subject to the Maximum Upside Return}$$
  
 If the Final Value is equal to the Initial Value or is less than the Initial Value by up to the Buffer Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:  

$$1,000 + (\$1,000 \times \text{Absolute Index Return})$$
  
*This payout formula results in an effective cap of 15.00% on your return at maturity if the Index Return is negative. Under these limited circumstances, your maximum payment at maturity is \$1,150.00 per \$1,000 principal amount note.*  
 If the Final Value is less than the Initial Value by more than the Buffer Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:  

$$\$1,000 + [\$1,000 \times (\text{Index Return} + \text{Buffer Amount})]$$
  
*If the Final Value is less than the Initial Value by more than the Buffer Amount, you will lose some or most of your principal amount at maturity.*

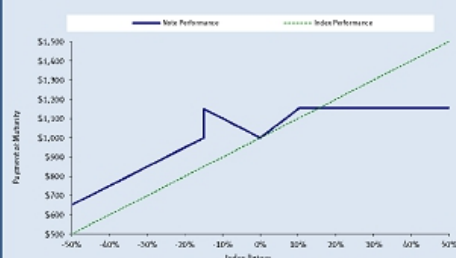
