

Hypothetical Examples of Amounts Payable at Maturity

The following examples illustrate how the total returns set forth in the table and graph above are calculated.

Example 1: The level of the Index increases from the Initial Index Level of 4250 to an Ending Index Level of 4462.50. Because the Ending Index Level of 4462.50 is greater than the Initial Index Level of 4250 and the Index Return of 5% multiplied by 2 does not exceed the Maximum Total Return of 19.40%, the investor receives a payment at maturity of \$1,100 per \$1,000 principal amount note, calculated as follows:

$$1,000 + [1,000 \times (5\% \times 2)] = 1,100$$

Example 2: The level of the Index decreases from the Initial Index Level of 4250 to an Ending Index Level of 3825.

Because the Ending Index Level of 3825 is less than the Initial Index Level of 4250 by not more than the Buffer Amount of 10%, the investor will receive a payment at maturity of \$1,000 per \$1,000 principal amount note.

Example 3: The level of the Index increases from the Initial Index Level of 4250 to an Ending Index Level of 5312.50. 
Selected Risk Considerations
