## Automatic Call

If on any Review Date (other than the first, second and final Review Dates) the closing level of each Underlying is **greater than or equal** to its Initial Value, the notes will be automatically called and you will receive a cash payment for each \$1,000 principal amount note, equal to (a) \$1,000 plus (b) the Contingent Interest Payment applicable to that Review Date, payable on the applicable Call Settlement Date. No further payments will be made on the notes.

## Payment at Maturity

If the notes have not been automatically called and the Final Value of each Underlying is **greater than or equal** to its respective Trigger Value, you will receive a cash payment at maturity, for each \$1,000 principal amount note, equal to (a) \$1,000 plus (b) the Contingent Interest Payment applicable to the final Review Date.

If the notes have not been automatically called and the Final Value of any Underlying is **less than** its Trigger Value, your payment at maturity per \$1,000 principal amount note will be calculated as follows:  

$$\$1,000 + (\$1,000 \times \text{Least Performing Underlying Return})$$

## Selected Risks (continued)
