

## 1.5yr SPX Capped Buffered Equity Notes

The following is a summary of the terms of the notes offered by the preliminary pricing supplement highlighted below.

## Summary of Terms

**Issuer:** JPMorgan Chase Financial Company LLC

**Guarantor:** JPMorgan Chase & Co.

**Minimum Denomination:** \$1,000

**Index:** S&P 500® Index

**Pricing Date:** March 26, 2020

**Observation Date:** September 27, 2021

**Maturity Date:** September 30, 2021

**Maximum Return:** At least 10.00%\*

**Buffer Amount:** 10.00%

**Downside Leverage Factor:** An amount equal to  $1 / (1 - \text{Buffer Amount})$ , which is 1.1111

**Payment At Maturity:** If the Final Value is greater than the Initial Value, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Index Return}), \text{ subject to the Maximum Return}$$

If the Final Value is equal to the Initial Value or is less than the Initial Value by up to the Buffer Amount, you will receive the principal amount of your notes at maturity.

If the Final Value is less than the Initial Value by more than the Buffer Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + [\$1,000 \times (\text{Index Return} + \text{Buffer Amount}) \times \text{Downside Leverage Factor}]$$

If the Final Value is less than the Initial Value by more than the Buffer Amount, you will receive some or all of your principal amount at maturity.
