Payment At Maturity:

If the Final Value is equal to or less than the Initial Value, your payment at maturity will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Index Return})$$

In no event, however, will the payment at maturity be less than \$900.00 per \$1,000 principal amount note.

If the Final Value is less than the Initial Value, you will lose up to 10.00% of your principal amount at maturity.

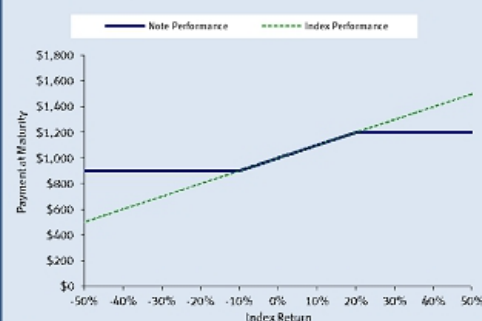

Selected Risks
