

## 15m SPX/RTY/INDU Capped Accelerated Barrier Notes

The following is a summary of the terms of the notes offered by the preliminary pricing supplement hyperlinked below.

## Summary of Terms

**Minimum Denomination:** \$1,000  
**Indices:** S&P 500® Index, Russell 2000® Index and Dow Jones Industrial Average™  
**Pricing Date:** March 26, 2021  
**Observation Date:** June 27, 2022  
**Maturity Date:** June 30, 2022  
**Maximum Return:** At least 14.25%\*  
**Upside Leverage Factor:** 1.50  
**Barrier Amount:** With respect to each Index, 70.00% of its Initial Value  
**Payment At Maturity:** If the Final Value of each Index is greater than its Initial Value, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$\$1,000 + (\$1,000 \times \text{Least Performing Index Return} \times \text{Upside Leverage Factor})$ , subject to the Maximum Return

If the Final Value of any Index is equal to or less than its Initial Value but the Final Value of each Index is greater than or equal to its Barrier Amount, you will receive the principal amount of your notes at maturity.

If the Final Value of any Index is less than its Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$\$1,000 + \$1,000 \times (\text{Least Performing Index Return})$

*If the Final Value of any Index is less than its Barrier Amount, you will lose more than 30.00% of your principal amount at maturity and could lose all of your principal amount at maturity.*

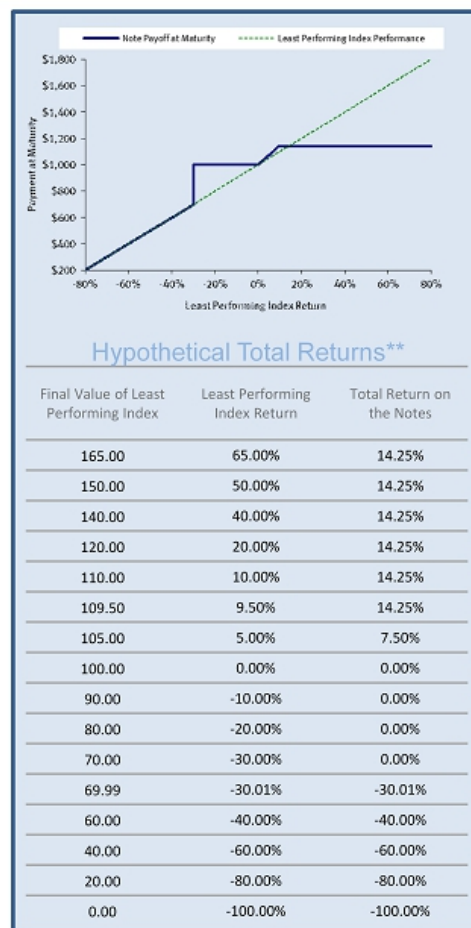
