 $\$1,000 + (\$1,000 \times \text{Least Performing Index Return})$

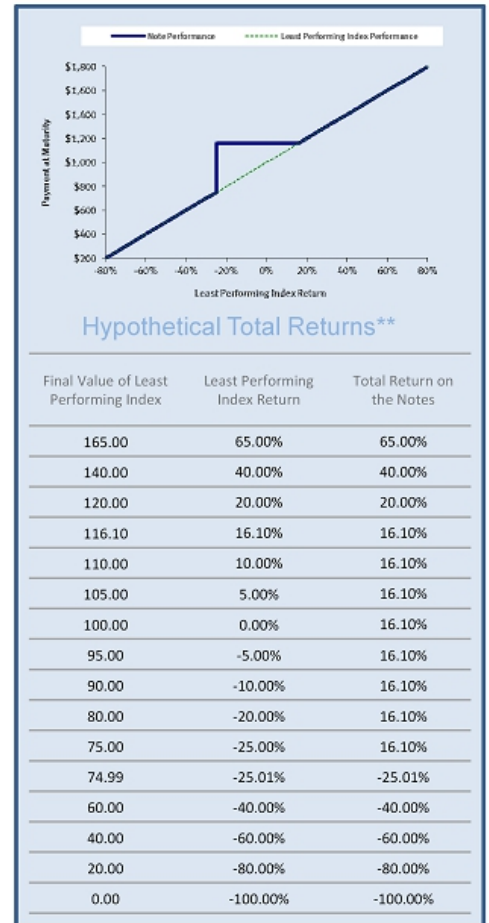
