

18m SPX Capped Dual Directional Buffered Equity Notes

The following is a summary of the terms of the notes offered by the preliminary pricing supplement highlighted below.

Summary of Terms

Minimum Denomination: \$1,000
Underlying: S&P 500® Index
Pricing Date: October 31, 2022
Observation Date: April 30, 2024
Maturity Date: May 3, 2024
Maximum Upside Return: At least 20.55%*
Buffer Amount: 20.00%
Payment At Maturity: If the Final Value is greater than the Initial Value, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Underlying Return}),$$

subject to the Maximum Upside Return

If the Final Value is equal to the Initial Value or is less than the Initial Value by up to the Buffer Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Absolute Underlying Return})$$

This payout formula results in an effective cap of 20.00% on your return at maturity if the Underlying Return is negative. Under these limited circumstances, your maximum payment at maturity is \$1,200.00 per \$1,000 principal amount note.

If the Final Value is less than the Initial Value by more than the Buffer Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + [\$1,000 \times (\text{Underlying Return} + \text{Buffer Amount})]$$

If the Final Value is less than the Initial Value by more than the Buffer Amount, you will lose some or most of your principal amount at maturity.

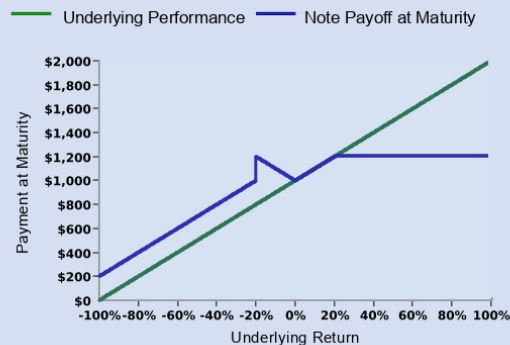
