

## 5yr Uncapped Dual Directional Accelerated Barrier Notes linked to Least Performing of SPX/RTY/INDU

The following is a summary of the terms of the notes offered by the preliminary pricing supplement hyperlinked below.

## Summary of Terms

**Index:** S&P 500® Index, Russell 2000® Index and Dow Jones Industrial Average™  
**Pricing Date:** July 30, 2021  
**Observation Date:** July 28, 2026  
**Maturity Date:** July 31, 2026  
**Upside Leverage Factor:** At least 1.05\*  
**Barrier Amount:** With respect to each Index, 70.00% of its Initial Value  
**Payment At Maturity:** If the Final Value of each Index is greater than its Initial Value, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Least Performing Index Return} \times \text{Upside Leverage Factor})$$

If the Final Value of any Index is equal to or less than its Initial Value but the Final Value of each Index is greater than or equal to its Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$1,000 + (\$1,000 \times \text{Absolute Index Return of the Least Performing Index})$$

*This payout formula results in an effective cap of 30.00% on your return at maturity if the Least Performing Index Return is negative. Under these limited circumstances, your maximum payment at maturity is \$1,300.00 per \$1,000 principal amount note.*

If the Final Value of any Index is less than its Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Least Performing Index Return})$$

*If the Final Value of any Index is less than its Barrier Amount, you will lose more than 30.00% of your principal amount at maturity and could lose all of your principal amount at maturity.*

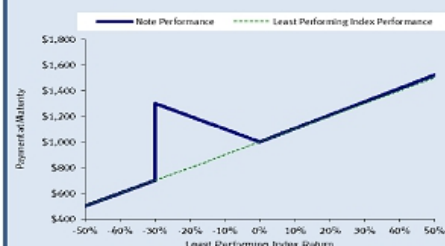
