

## 3yr INDU/NDX Uncapped Dual Directional Accelerated Barrier Notes

The following is a summary of the terms of the notes offered by the preliminary pricing supplement highlighted below.

## Summary of Terms

**Issuer:** JPMorgan Chase Financial Company LLC  
**Guarantor:** JPMorgan Chase & Co.  
**Minimum Denomination:** \$1,000  
**Underlyings:** Dow Jones Industrial Average™ and NASDAQ-100 Index®  
**Pricing Date:** January 31, 2023  
**Observation Date:** February 2, 2026  
**Maturity Date:** February 5, 2026  
**Upside Leverage Factor:** At least 1.10\*  
**Barrier Amount:** With respect to each Underlying, 70.00% of its Initial Value  
**Payment At Maturity:** If the Final Value of each Underlying is greater than its Initial Value, your payment at maturity per \$1,000 principal amount note will be calculated as follows:  

$$\$1,000 + (\$1,000 \times \text{Lesser Performing Underlying Return} \times \text{Upside Leverage Factor})$$
  
 If the Final Value of either Underlying is equal to or less than its Initial Value but the Final Value of each Underlying is greater than or equal to its Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:  

$$\$1,000 + (\$1,000 \times \text{Absolute Underlying Return of the Lesser Performing Underlying})$$
  
*This payout formula results in an effective cap of 30.00% on your return at maturity if the Lesser Performing Underlying Return is negative. Under these limited circumstances, your maximum payment at maturity is \$1,300.00 per \$1,000 principal amount note.*  
 If the Final Value of either Underlying is less than its Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:  

$$\$1,000 + (\$1,000 \times \text{Lesser Performing Underlying Return})$$
  
*If the Final Value of either Underlying is less than its Barrier Amount, you will lose more than 30.00% of your principal amount at maturity and could lose all of your principal amount at maturity.*

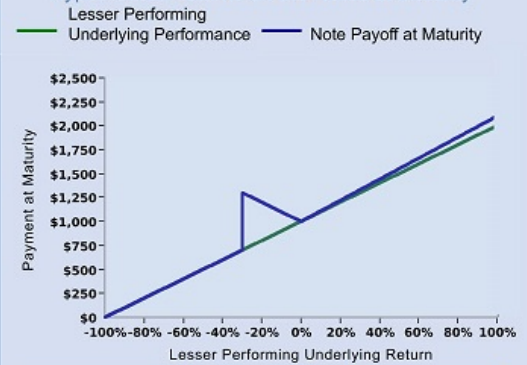
