

## 5yr SPX/RTY Uncapped Dual Directional Contingent Buffered Equity Notes

The following is a summary of the terms of the notes offered by the preliminary pricing supplement highlighted below.

## Summary of Terms

**Indices:** S&P 500® Index and Russell 2000® Index  
**Pricing Date:** February 25, 2020  
**Observation Date:** February 25, 2025  
**Maturity Date:** February 28, 2025  
**Contingent Minimum Return:** At least 17.00%\*  
**Contingent Buffer Amount:** 30.00%  
**Payment At Maturity:** If the Final Value of each Index is greater than or equal to its Initial Value, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$\$1,000 + (\$1,000 \times \text{greater of (a) the Contingent Minimum Return and (b) the Lesser Performing Index Return})$

If (i) the Final Value of one Index is greater than or equal to its Initial Value and the Final Value of the other Index is less than its Initial Value by up to the Contingent Buffer Amount or (ii) the Final Value of each Index is less than its Initial Value by up to the Contingent Buffer Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$\$1,000 + (\$1,000 \times \text{Absolute Index Return of the Lesser Performing Index})$

If the Final Value of either Index is less than its Initial Value by more than the Contingent Buffer Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$\$1,000 + (\$1,000 \times \text{Lesser Performing Index Return})$

*If the Final Value of either Index is less than its Initial Value by more than the Contingent Buffer Amount, you will lose more than 30.00% of your principal amount at maturity and could lose all of your principal amount at maturity.*

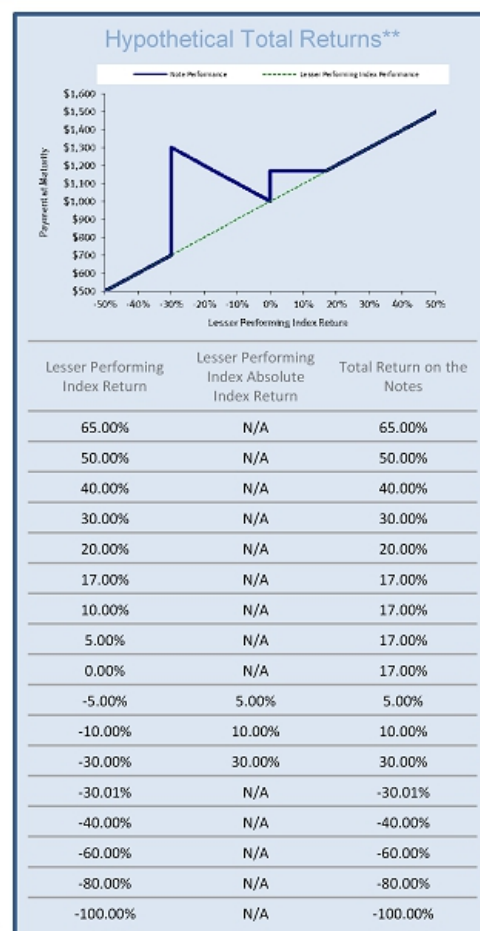
