Payment at Maturity

If the Final Value is greater than or equal to the Initial Value or less than the Initial Value by up to the Buffer Amount, you will receive a cash payment at maturity, for each \$1,000 principal amount note, equal to (a) \$1,000 plus (b) the Interest Payment applicable to the Maturity Date.

If the Final Value is less than the Initial Value by more than the Buffer Amount, your payment at maturity per \$1,000 principal amount note, in addition to the Interest Payment applicable to the Maturity Date, will be calculated as follows:

$$\$1,000 + [\$1,000 \times (\text{Index Return} + \text{Buffer Amount})]$$

If Final Value is less than the Initial Value by more than the Buffer Amount, you will lose some or most of your principal amount at maturity.
