### General


What Is the Total Return on the Notes at Maturity Assuming a Range of Performance for the Index?

The following table and graph illustrate the hypothetical total return at maturity on the notes. The "total return" as used in this term sheet is the number, expressed as a percentage, that results from comparing the payment at maturity per \$1,000 principal amount note to \$1,000. The hypothetical total returns set forth below assume an Initial Index Level of 18200 and a Maximum Total Return on the notes of 18.80%. ## Hypothetical Examples of Amounts Payable at Maturity

The following examples illustrate how the total returns set forth in the table and graph above are calculated.

**Example 1:** The level of the Index increases from the Initial Index Level of 18200 to an Ending Index Level of 19110. Because the Ending Index Level of 19110 is greater than the Initial Index Level of 18200 and the Index Return of 5% multiplied by 2 does not exceed the hypothetical Maximum Total Return of 18.80%, the investor receives a payment at maturity of \$1,100 per \$1,000 principal amount note, calculated as follows:

$$1,000 + [1,000 \times (5\% \times 2)] = 1,100$$

**Example 2: The level of the Index decreases from the Initial Index Level of 18200 to an Ending Index Level of 16380.** Because the Ending Index Level of 16380 is less than the Initial Index Level of 18200 by not more than the Buffer Amount of 10%, the investor receives a payment at maturity of \$1,000 per \$1,000 principal amount note.

**Example 3: The level of the Index increases from the Initial Index Level of 18200 to an Ending Index Level of 21840.** Because the Ending Index Level of 21840 is greater than the Initial Index Level of 18200 and the Index Return of 20% multiplied by 2 exceeds the hypothetical Maximum Total Return of 18.80%, the investor receives a payment at maturity of \$1,188 per \$1,000 principal amount note, the maximum payment on the notes.

**Example 4: The level of the Index decreases from the Initial Index Level of 18200 to an Ending Index Level of 14560.** Because the Ending Index Level of 14560 is less than the Initial Index Level of 18200 by more than the Buffer Amount of 10%, the Index Return is negative and the investor receives a payment at maturity of \$888.89 per \$1,000 principal amount note, calculated as follows:

## **Selected Purchase Considerations**

- APPRECIATION POTENTIAL The notes provide the opportunity to enhance equity returns by multiplying a positive Index Return by two, up to the Maximum Total Return on the notes of 18.80%, or \$1,188 for every \$1,000 principal amount note. The actual Maximum Total Return on the notes will be set on the pricing date and will not be less than 18.80%. Because the notes are our senior unsecured obligations, payment of any amount at maturity is subject to our ability to pay our obligations as they become due.
- **LIMITED PROTECTION AGAINST LOSS** Payment at maturity of the principal amount of the notes is protected against a decline in the Ending Index Level, as compared to the Initial Index Level, of up to 10%. If the Ending Index Level declines by more than 10%, for every 1% decline of the Index beyond 10%, you will lose an amount equal to 1.1111% of the principal amount of your notes.



- YOUR INVESTMENT IN THE NOTES MAY RESULT IN A LOSS The notes do not guarantee any return of principal. The return on the notes at maturity is linked to the performance of the Index and will depend on whether, and the extent to which, the Index Return is positive or negative. Your investment will be exposed on a leveraged basis to any decline in the Ending Index Level beyond the 10% buffer as compared to the Initial Index Level.
