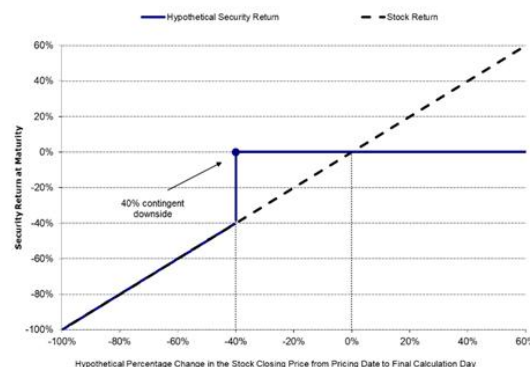
Summary of Terms

Underlying Stock:	The common stock of Tesla, Inc. (Bloomberg Ticker: TSLA) (the “Underlying Stock”)

Stated Maturity Date ^{1, 2} :	June 29, 2026
Principal Amount:	\$1,000 per security (100% of par)
Contingent Coupon Payment:	On each contingent coupon payment date, you will receive a contingent coupon payment at a per annum rate equal to the contingent coupon rate if, and only if , the stock closing price of the Underlying Stock on the related calculation day is greater than or equal to the threshold price. Each “contingent coupon payment,” if any, will be calculated per security as follows: $(\$1,000 \times \text{contingent coupon rate}) / 4$
Contingent Coupon Payment Dates ^{1, 2} :	Quarterly, on the third business day following each calculation day, <i>provided</i> that the contingent coupon payment date with respect to the final calculation day will be the stated maturity date
Contingent Coupon Rate:	At least 19.05% per annum (to be provided in the pricing supplement)
Automatic Call:	If the stock closing price of the Underlying Stock on any of the calculation days from December 2023 to March 2026, inclusive, is greater than or equal to the starting price, the securities will be automatically called, and on the related call settlement date you will be entitled to receive a cash payment per security in U.S. dollars equal to the principal amount per security <i>plus</i> a final contingent coupon payment.
Calculation Days ^{1, 2} :	Quarterly, on the 24th day of each March, June, September and December, commencing September 2023 and ending June 2026. We refer to June 24, 2026 as the “final calculation day.”

Fees and Commissions:	Up to 2.325% for Wells Fargo Securities, LLC (“WFS”); WFS has advised us that dealers, including Wells Fargo Advisors (“WFA”), may receive 1.75% of WFS’s fee, and WFA may also receive a distribution expense fee of 0.075%. In addition, with respect of certain securities sold in this offering, JPMS may pay a fee of up to 0.10% to selected dealers in consideration for marketing and other services in connection with the distribution of the securities to other dealers.

If the securities are not automatically called prior to maturity and the ending price is less than the threshold price, you will lose more than 40%, and possibly all, of the principal amount of your securities at maturity.

Any return on the securities will be limited to the sum of your contingent coupon payments, if any. You will not participate in any appreciation of the Underlying Stock, but you will have full downside exposure to the Underlying Stock on the final calculation day if the ending price is less than the threshold price.
