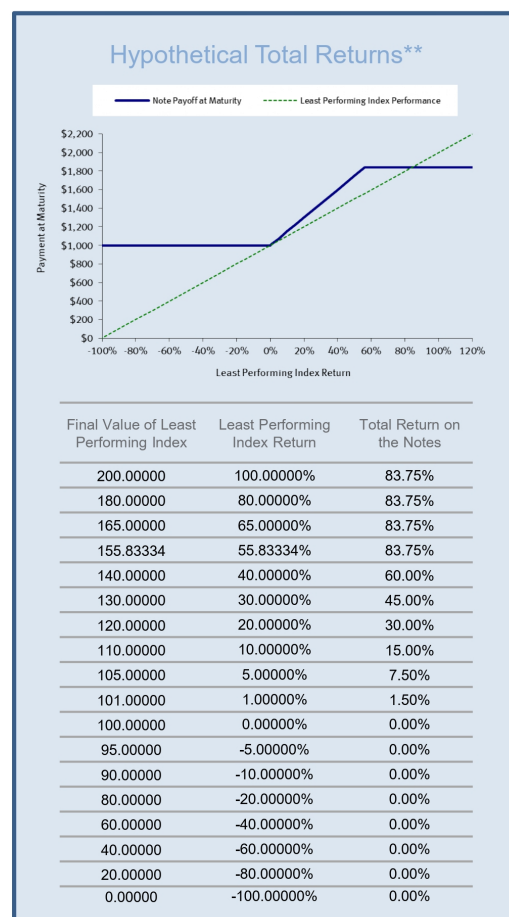

## Selected Risks
