

## 5yr Partial Principal at Risk Notes linked to SX5E/EFA

The following is a summary of the terms of the notes offered by the preliminary pricing supplement hyperlinked below.

## Summary of Terms

**Underlyings:** EURO STOXX 50® Index (the "Index") and iShares® MSCI EAFE ETF (the "Fund")

**Participation Rate:** At least 125.00%\*  
**Additional Amount:** \$1,000 × Lesser Performing Underlying Return × Participation Rate  
**Payment At Maturity:**

If the Final Value of each Underlying is greater than its Initial Value, at maturity, you will receive a cash payment, for each \$1,000 principal amount note, of \$1,000 plus the Additional Amount.

If (i) the Final Value of one Underlying is greater than its Initial Value and the Final Value of the other Underlying is equal to its Initial Value or (ii) the Final Value of each Underlying is equal to or less than its Initial Value, your payment at maturity will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Lesser Performing Underlying Return})$$

In no event however, will the payment at maturity be less than \$950.00 per \$1,000 principal amount note.

*If the Final Value of either Underlying is less than its Initial Value, you will lose up to 5.00% of your principal amount at maturity.*

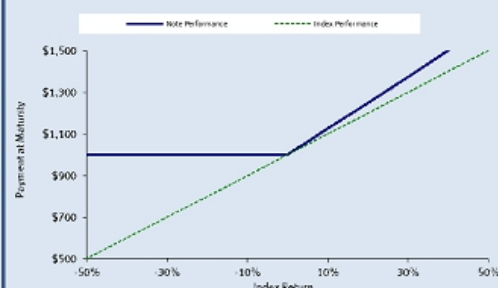

## Selected Risks
