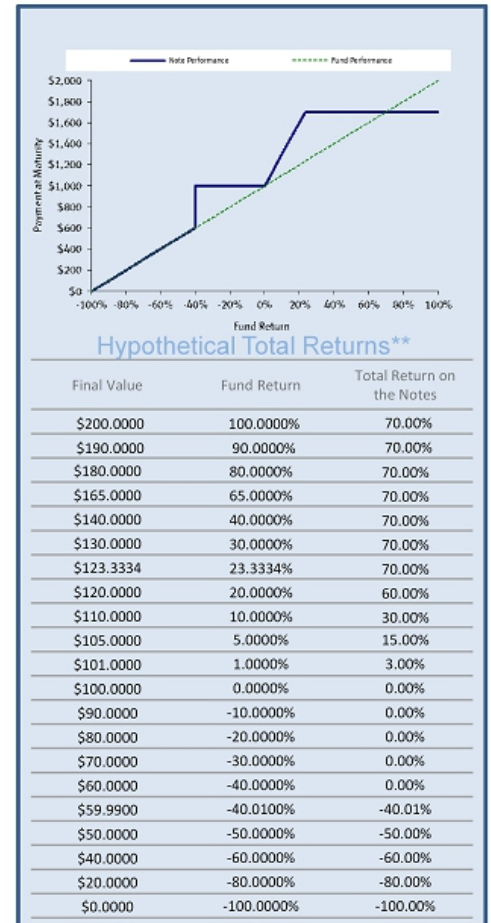

Selected Risks (continued)
