

3yr Capped Dual Directional Barrier Notes linked to Lesser Performing of NDX/INDU

The following is a summary of the terms of the notes offered by the preliminary pricing supplement hyperlinked below.

Payment At Maturity: If the Final Value of each Index is greater than its Initial Value, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Lesser Performing Index Return}), \text{ subject to the Maximum Upside Return}$$

 If the Final Value of either Index is equal to or less than its Initial Value but the Final Value of each Index is greater than or equal to its Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$1,000 + (\$1,000 \times \text{Absolute Index Return of the Lesser Performing Index})$$

This payout formula results in an effective cap of 25.00% on your return at maturity if the Lesser Performing Index Return is negative. Under these limited circumstances, your maximum payment at maturity is \$1,250.00 per \$1,000 principal amount note.
 If the Final Value of either Index is less than its Barrier Amount, your payment at maturity per \$1,000 principal amount note will be calculated as follows:

$$\$1,000 + (\$1,000 \times \text{Lesser Performing Index Return})$$

If the Final Value of either Index is less than its Barrier Amount, you will lose more than 25.00% of your principal amount at maturity and could lose all of your principal amount at maturity.

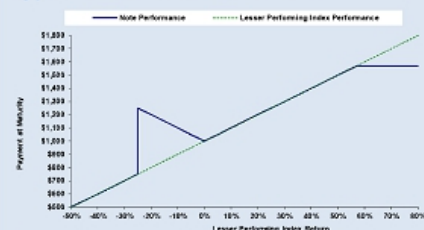
