The section entitled "Comparable Yield and Projected Payment Schedule" in the pricing supplement dated December 27, 2022, related to the notes referred to above (the "pricing supplement"), is amended, restated and superseded in its entirety by the following:

Comparable Yield and Projected Payment Schedule

We have determined that the "comparable yield" is an annual rate of 4.89%, compounded quarterly. Based on our determination of the comparable yield, the "projected payment schedule" per \$1,000 principal amount note consists of the following payments:
