

## 3yr NKY/SPX/RTY Contingent Income Callable Securities

**This document provides a summary of the terms of the securities. <b>Issuer:</b>	JPMorgan Chase Financial Company LLC ("JPMorgan Financial")
<b>Guarantor:</b>	JPMorgan Chase & Co.
<b>Underlying indices:</b>	Nikkei 225 Index (Bloomberg Ticker: NKY Index) (the "NKY Index"), S&P 500 <sup>®</sup> Index (Bloomberg Ticker: SPX Index) (the "SPX Index") and Russell 2000 <sup>®</sup> Index (Bloomberg Ticker: RTY Index) (the "RTY Index") (each an "underlying index")
<b>Optional early redemption:</b>	We, at our discretion, may redeem the securities early, in whole but not in part, on any of the contingent payment dates (other than the final contingent payment date) for the early redemption payment. If we intend to redeem your securities early, we will deliver notice to The Depository Trust Company, or DTC, at least three business days before the applicable contingent payment date. Any early redemption of the securities will be at our discretion and will not automatically occur based on the performance of the underlying indices. No further payments will be made on the securities once they have been redeemed.
<b>Early redemption payment:</b>	The early redemption payment will be an amount equal to (i) the stated principal amount <i>plus</i> (ii) any contingent quarterly payment otherwise due with respect to the quarterly monitoring period.
<b>Contingent quarterly payment:</b>	<ul style="list-style-type: none"> <li>If the closing level of each underlying index is greater than or equal to its downside threshold level on each day during a quarterly monitoring period, we will pay a contingent quarterly payment of at least \$21.875 (at least 2.1875% of the stated principal amount) per security on the related contingent payment date. The actual contingent quarterly payment will be provided in the pricing supplement.</li> <li>If the closing level of <b>any underlying index</b> is less than its downside threshold level on <b>any</b> day during a quarterly monitoring period, no contingent quarterly payment will be payable with respect to that quarterly monitoring period. <b>It is possible that one or more of the underlying indices will be below their respective downside threshold levels on at least one day during most or all of the quarterly monitoring periods so that you will receive few or no contingent quarterly payments.</b></li> </ul>
<b>Payment at maturity:</b>	<ul style="list-style-type: none"> <li>If the final index value of <b>each</b> underlying index is <b>greater than or equal to</b> its downside threshold level: (i) the stated principal amount <i>plus</i>, (ii) if the closing level of each underlying index on each day during the final quarterly monitoring period is greater than or equal to its downside threshold level, the contingent quarterly payment with respect to the final quarterly monitoring period.</li> <li>If the final index value of <b>any</b> underlying index is <b>less than</b> its downside threshold level: (i) the stated principal amount <i>times</i> (ii) the index performance factor of the worst performing underlying index. This cash payment will be less than 65% of the stated principal amount of the securities and could be zero.</li> </ul>
<b>Downside threshold level:</b>	With respect to each underlying index, 65% of its initial index value
<b>Quarterly monitoring period:</b>	With respect to each contingent payment date, the period from but excluding the second immediately preceding determination date (or, in the case of the first determination date, from but excluding the pricing date) to and including the immediately preceding determination date
<b>Initial index value:</b>	With respect to each underlying index, its closing level on the pricing date
<b>Final index value:</b>	With respect to each underlying index, its closing level on the final determination date
<b>Worst performing underlying index:</b>	The underlying index with the worst index performance factor
<b>Index performance factor:</b>	With respect to each underlying index, the final index value <i>divided by</i> the initial index value

<b>Issue price:</b>	\$1,000 per security
